## The Carnwith Mansion

Walter Campbell noticed the beauty of the house on the corner of Baldwin St. and Colston Ave., known to Brooklinites as the Carnwith Mansion. Observing that the building fit in with his Victorian architecture theme, he was thus inspired to paint it. All 850 signed and numbered limited edition prints from his "Winter in the Country" theme were nearly sold out at the wholesale level before it was printed.

Built in 1859 for Stephen Mead Thomas, the 14-room brick house was previously owned by a series of 10 families before James and Wilma Carnwith bought it in 1948 and moved in with their four children. The 25-acre property boasted a stable, a three-car garage, a five-room bungalow for staff, three acres of apple orchard, a smoke house, an apple barn, a wooden pergola and a stream that was damned for swimming.

A by-law was passed on May 14, 1984, authorizing its Heritage designation because of its architectural and historical value. Then in 1989, the building was purchased and renovated by the Renaissance Fellowship Foundation Inc., and today is the Paul J. Sullivan rehab centre for men.

# Best Centre Receiving Gov't Fund

Smoothies and...Moss

I'm a huge fan of smoothies.

I like that they're fast to make and I can pack them full of micronutrients. My morning smoothie always has something green in it, like frozen kale or spinach as well as some and protein.

Lately, I've been buying smoothies from a Whitby woman who's opening a restaurant in Oshawa called "The Portobello Road." Her smoothies are sold in one-litre mason jars and one smoothie will last me two or three days. They're a great convenience and packed fruit, hemp seeds and, my

new favourite ingredient, Irish Sea Moss. Irish Sea Moss has been touted as a superfood. It's a vegan, gluten-free source of many nutrients that include:

- Vitamin B2 • Vitamin B12 (Vegans need this)
- Calcium • Chromium
- Magnesium • Zinc

Containing no sugar and with just five calories per tablespoon (one serving = two tablespoons), it's supposedly nutrient-dense. Evidently, the sea moss benefits seem miraculous,

However, I should mention that many claims are unproven and my research found contradictory information. So, as with everything, try it, see if it works, first ensuring it doesn't interfere with any medications.

Iodine warning

Sea moss is also said to be a source of iodine, which is something you can eat too much of. Excessive iodine in your diet can lead to goitre or enlargement of the thyroid gland, so be sure to stick to one serving per day.

The best way to evaluate a supplement is to read its benefits and determine if you require them. Years ago, I would look to supplements to help fix more lifestyle-related problems, like needing more sleep or a vacation or a few days of rest. We all get tired or overworked, so with some contemplative thinking, you can determine what you need: more rest or a supplement. If you're going to try the supplement, evaluate if it's making a difference.

At my studio, when clients ask about supplements for a problem they're experiencing, I always suggest they first see their doctor and perhaps have blood work

done. This way they have a clearer picture of the problem.

Green Smoothie Recipe (Serves 2)

- 1 cup unsweetened almond or any unsweetened nut milk
  - 1-2 handfuls of spinach (frozen breaks down the best)
  - 2 frozen bananas
  - 2-4 soft pitted dates (pre-soak these the night before if you have time).
  - 2 tbsp hemp hearts
  - 1 tbsp natural peanut butter
  - 2 ice cubes
  - Optional Add-in - 2 tablespoons Irish Sea Moss Gel.
  - Optional Add-in - 1 scoop protein powder
- Combine all ingredients, blend on high until smooth and frothy.

**Sheree's hack:** Keep all your seeds (hemp, flax and chia) in the freezer to extend their shelf lives.

REVISED NOTICE OF COMPLETION

Filing of Addendum to the Municipal Class Environmental Assessment Reconstruction of White's Bridge on Columbus Road west of Country Lane (Schedule B)

Background:

In November 2011, the Town of Whitby (Town) completed a Schedule 'B' Municipal Class Environmental Assessment (Environmental Assessment) for the replacement of White's Bridge on Columbus Road west of Country Lane (Notice of Completion issued November 25, 2011). Full reconstruction of the existing bridge was considered to be the best solution to address safety issues, and maintain the viability of the road as an important Municipal arterial route for the movement of traffic.

Proposed Modifications to the Project:

The preferred solution does not change from the 2011 evaluation. **Alternative 3 - Bridge Reconstruction** remains the preferred solution as it has the greatest overall benefit, most importantly to address safety. The Town undertook a review of the findings from the 2011 report to re-evaluate the various profile (vertical alignment) and centerline (horizontal alignment) alternatives that were originally considered within the current environmental setting as well as to guide future detailed design. The evaluation re-confirmed the vertical profile for the 2011 Project File Report (PFR) and recommends a horizontal alignment that maintains the existing centerline of Columbus Road and will be developed initially as a two lane bridge, but constructed to accommodate the ultimate future four lane bridge cross section.

Addendum Process:

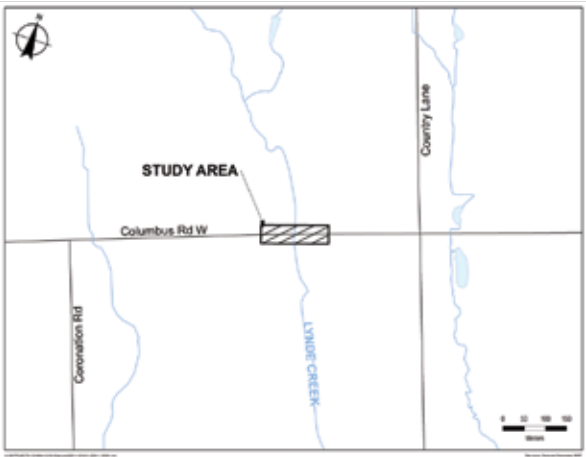
In accordance with the Municipal Engineers Association Class EA process, "if the period of time from filing of the Notice of Completion to the proposed commencement of construction for the

project exceeds ten (10) years, the proponent shall review the planning and design process to ensure that the project and the mitigating measures are still valid given the current planning context". With this in mind, there are permits and approvals that are required which will not allow the Town to be in a position to commence construction prior to the 10 year time lapse. The Town has prepared this Addendum which describes the details and justification for the proposed changes as well as a description of the current environmental setting.

This Addendum and the original PFR are available for an extended 40-day public viewing period to provide additional review time that falls over the holidays. The review period is between **December 7, 2020 and January 15, 2021** and the documentation will be posted on the Town's website at [whitby.ca/whitesbridge](http://whitby.ca/whitesbridge).

It should be noted that only the proposed changes outlined in this Addendum are subject to review. The comments, including any issues or concerns, should be sent first to GHD Limited for potential resolution.

During the extended 40 calendar day review period, if there are outstanding concerns that the Project may adversely impact constitutionally protected Aboriginal and treaty rights, which cannot be resolved in discussion with the Town, then a person or party may request that the Minister of the Environment, Conservation and Parks make an order for the Project to comply with Part II of the Environmental Assessment Act. Requests on other grounds will not be considered. This is referred to as a Part II Order, which addresses Individual Environmental Assessments.

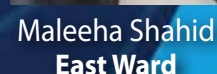

Highway 7/12 Alternative Route(s) EA

Highway 7/12 currently travels through Downtown Brooklin in the Town of Whitby. The Town has initiated a Provincial Class Environmental Assessment (EA) Study to determine an alternative route(s) for provincial traffic that does not go through the Downtown Brooklin area. The Study will evaluate alternative corridors and recommend a preferred plan to address both the local and provincial traffic needs of the Study Area.



In recognition of the Ministry of Transportation (MTO) ownership and control of existing Highway 7 and 12 and future alternative route(s), the Study is being conducted as a Group A EA Study under the MTO Class Environmental Assessment for Provincial Transportation Facilities (2000). The MTO Class EA Document permits the Town to act as the Proponent. The Study will complete all phases of the

MTO Class EA Process by establishing the need and justification for the project, evaluating route alternatives and selecting a preferred plan with consideration of effects on the natural, social and cultural environments.

The purpose of OCOH No. 2 is to present the preliminary transportation analysis and development of a short list of alternative corridors to be carried forward for detailed evaluation. As with OCOH No. 1, the Town wishes to ensure that anyone interested in this study has the opportunity to be involved and provide input. Given that the COVID-19 pandemic related restrictions continue to be in place, OCOH No. 2 will also be relying on web-based communications.
