

## TOWN COUNCIL MEETING February 15, 2021

The Town Council met February 15, 2021 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:04p.m. Council Member Crumpton gave the invocation.

Mayor Hight asked for approval of the Council Minutes from February 1, 2021.

Council Member Killingworth moved to approve the Council Minutes from February 1, 2021 as presented. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

**New Business**

Mayor Hight stated that the council has a copy of the Resolution for the MWPP (Municipal Water Pollution Prevention) that must be sent to ADEM each year.

Council Member Littleton moved to approve the Resolution for the MWPP for 2020. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Mayor Hight stated next on the agenda was the hearings for Zoning Ordinance Violations.

David Nunn from 1202 W. Medical Center Dr. explained to the council he had contacted his tenants and they are cleaning the property up. Mr. Nunn thanked the council for contacting him about the violation.

Debra Jones was there for Cora Smith from 472 Indiana Ave. She stated they had been working on cleaning the property up.

Mayor Hight explained that she has 5 days to get the property cleaned up or the Town will clean the property up and put a lean on the property.

Council Member Killingworth moved to approve the clean up and put a lean on property at 472 Indiana Ave. if not cleaned in 5 days. Council Member Chapman seconded motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

No one was present for John Dickerson at 1980 W. Medical Center Dr.

Council Member Crumpton moved to approve the clean up and put a lean on property at 1980 W. Medical Center Dr. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

#### Department Heads

Chief Barnett gave the Council a copy of his activity sheet for January.

Chief Barnett explained to the Council he had interviewed Keith Avery for the full-time police officer position and asked the Council for their approval to hire Keith Avery eff. March 1, 2021 as a full-time officer, he would be replacing Forrest Silas that is retiring as of March 1, 2021.

Council Member Killingsworth moved to hire Keith Avery as a full-time police officer starting March 1,2021. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Killingworth, Littleton, Benson Chapman and Crumpton.

Fire Chief Parker was not present at the time. Mayor Hight stated he is attending the meeting for the new ambulance service for the county.

Daniel Avery had none at this time.

Council Member Littleton asked were the wells up and running right. Daniel stated that the water computer system still needs working on and he is just waiting on Don Cross. Daniel also stated the Garbage truck is in the shop and they are using one from the City of Clanton.

Council Member Killingworth is asked about the Mowers. Daniel stated all mowers are ready.

Town Clerk Crystal Smith had none at this time.

Council Member Littleton moved to approve the transfer of funds, and bills for February 15, 2021. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Crumpton, Chapman, Killingworth, and Benson.
