The notion of a one book/one city started with an idea by Seattle librarian Nancy Pearl. First initiated in 1998 by the Washington Center for the Book, the Library of Congress reports that such programs are abundant around the world.



## I Am a Man: Chief Standing Bear's Journey for Justice~ About This Year's Selection:

In January 2026, the Wilson Public Library in Cozad, NE, launches their eleventh One Book One Cozad program with the selection of *I Am a Man: Chief Standing Bear's Journey for Justice* by Joe Starita.

147 years ago in May, Chief Standing Bear of the Ponca Tribe stood before a judge in Omaha to plead his case for his civil rights. He successfully used *habeas corpus*, the only liberty included in the original wording of the Constitution, to gain access to that federal court.

The Ponca Tribe, farmers and churchgoers who sent their children to school, had been rounded up by the United States government and forcibly moved to a reservation in Oklahoma two years earlier. Many lost their lives, including two of Standing Bear's children. His son's dying wish to be buried with his relatives prompted Standing Bear to set off on a 600 mile journey back to Nebraska. Ultimately, he was arrested by General George Crook. Crook, who had orders to send Standing Bear back to Indian Territory, worked behind the scenes to help publicize the case and became an unlikely ally.

**"That hand is not the color of yours, but if I pierce it, I shall feel pain. If you pierce your hands, you also feel pain. The blood that will flow from mine will be of the same color as yours. I am a man. The same God made us both."**

## The Author: Joe Starita



Joe Starita was born in Lincoln and recently retired from the College of Journalism and Mass Communications in 2021.

He has two Pulitzer Prize nominations, one for investigative reporting for the *Miami Herald*

and the other for his book, *The Dull Knives of Pine Ridge*. Starita also served as City Editor for the *Lincoln Journal Star*.

In 2012 Starita started the Chief Standing Bear Journey for Justice Scholarship Fund, which awards six to eight scholarships annually to Nebraska Native American high school graduates.

Starita's 2009 book *I Am a Man: Chief Standing Bear's Journey for Justice*, has been the 2011 One Book One Lincoln selection, the 2012 One Book One Nebraska selection, and was selected in 2017 as one of Nebraska's most notable 150 books for Nebraska's 150th anniversary.

He has received several state and national civil rights awards as well. His book about Chief Standing Bear's niece, Susan La Flesche, *A Warrior of the People: How Susan La Flesche Overcame Racial and Gender Inequality to Become America's First Indian Doctor*, was published in 2016.
