In the past two years, ADC has grown to represent over 30,000 dairy producers through memberships, as well as national and state dairy associations. ADC has collaborated with many groups and individuals to make a significant impact on the agriculture industry. Below details our current efforts:

- Lobbying directly with lawmakers to help move forward positive agriculture policies that will be advantageous to dairy producers nationally
- Securing a reliable labor force by working with legislators to introduce immigration reform bills. ADC was heavily involved in the following:
 - **The Dairy Act** introduced by Representative Sean Duffy (R-WI), Co-Chair of the Congressional Dairy Farmer Caucus
 - **The State-Based Visa Pilot Program** introduced by Senator Ron Johnson (R-WI), Chairman of the committee of the Homeland Security and Government Affairs
 - **The Ag Act (Agricultural Guestworker Act)** draft by Representative Bob Goodlatte (R-VA), Chairman of the House Judiciary Committee
- Watching the rules that the USDA develops regarding GMO labeling under the GMO bill. The bill provides the USDA with the authority and power to label our food products and this must be done correctly, based on science and fact
- Streamlining environmental regulations to reduce over-burdensome regulations
- Improving rural access to technology, healthcare and infrastructure
- Increasing the export of dairy and agriculture commodities for producers and allied industries
