I decided on running in Broward County based on proximity to my parents and a large voting population that will be hopefully less likely to discriminate against me being originally from and raised in New York.

Overall, I believe I am providing the voters an opportunity to make a decision on who should be their Judge, rather than Judge Deprimo, a Rick Scott former Governor's appointment, running unopposed. I don't believe that the voters in Broward County really want lawyers not to challenge recent appointments and take away their chance in deciding. Based on a recent Rick Scott appointment, the sitting Judge does not have a long-term track record as a Judge, nor has ever been on the ballot for the voters to decide on. Broward voters now have a chance on

deciding for themselves on who should serve as a Judge, instead of a select few privileged political insiders. Voters of Broward County now have a chance to decide on voting for a candidate that is someone less financially and politically privileged. Voters in Broward County should have a choice of who they vote for beyond the insider privileged or financially privileged and make their decision.
