LBV Historical Markers

- 1971 LBVCA formed
- 1972 Whitney Mountain Lodge groundbreaking
- 1973 Maintenance Assessment is \$36
- 1973 Lost Bridge Water and Sewer utility district formed
- 1974 First Walmart (annual) Convention
- 1976 Tennis Courts open
- 1977 Roger's population 15,000
- 1978 Boat Dock established at Rec center
- 1978 NEBCO Firehouse on Posy Mountain Rd erected
- 1979 Maintenance Assessment increase from \$24 to \$60
- 1982 VAS launched
- 1982 LBVCA Board term reduced from 6 to 3 years
- 1982 LBVCA Board members increased to 7 T/A's
- 1984 Proposed Maintenance Assessment increase to \$84 fails
- 1984 Lodge sold by owner/developer
- 1984 Original LBV developer, Sherwood Crane, dies
- 1984 Proposed Maintenance Assessment increase to \$96 fails
- 1985 New swimming pool
- 1986 Articles of Incorporation are re-written
- 1987 Revised collection procedures to include assignment to collection agency
- 1989 ACC procedures modified to require Board concurrence on variances
- 1993 Proposed assessment increase from \$60 yr. to \$96 yr. eff. Jan. 1995 (revised to \$72)
- 1994 Airstrip closed to vehicle traffic
- 1996 Covenant Compliance Committee formed
- 1998 Purchased new tractor
- 2000 LBV boat dock sold to highest bidder for \$16,777
- 2003 Assessment increase to \$96
