Stratton Property Tax Payer Information

We **do** accept timely, non-metered postmarks. Taxes can also be paid in full before the due date.

**For installments not paid by the due date, interest at the rate of 1% per month will be charged. All taxes unpaid after the final due date are delinquent and will be collected with 8% penalty and the 1% monthly interest rate.**

Other options of payment are the automatic payment program (ACH) and credit card payments. Automatic tax payments are deducted on each due date from the bank account that you specify.

Credit card payments may be made through Official Payments with a 3% transaction fee charged for this service. Credit card payment information is shown below and the enrollment form for the automatic payment program can be found on the other side of this notice.

To complete a credit card transaction you will need the following information:

1. The Jurisdiction code is #5511 (the Town Code).
2. The SPAN # 627-197-\_\_\_\_\_. These last 5 digits identify your parcel(s) and can be found in the upper right hand corner of your **original** tax bill or by calling the Stratton Town Office at 802-896-6184.
