ORDINANCE 131**

**SPECIAL EVENTS**

**COUNTY OF HENDERSON**

AN ORDINANCE PROVIDING FOR A SPECIAL FEE SCALE FOR EVENTS HELD IN THE CITY OF LOG CABIN DEEMED "SPECIAL EVENTS" BY THE CITY COUNCIL AND/OR MAYOR; PROVIDING FOR AUTOMATIC ENACTMENT OF THIS ORDINANCE; PROVIDING FOR RESTRUCTURING OF RV PARKING SPACES AND PRIMITIVE CAMPING DURING "SPECIAL EVENTS"; AND PROVIDING FOR FINES, PENALTIES, AND/OR COSTS INVOLVED WITH "SPECIAL EVENTS" IN THE CITY OF LOG CABIN, HENDERSON COUNTY, TEXAS.

**SECTION I. ADOPTION OF ORDINANCE.**

**WHEREAS**, in order to protect, promote and defend the health, safety and welfare of the inhabitants of the City of Log Cabin, Texas when large groups of people may enter and use our Park Facilities, Boat Ramp, and Red Barn for a special event, and to defray extra costs for Police, Maintenance Personnel, Park Attendants, etc. during these events, it is necessary to adopt a "Special Events" Ordinance for the City of Log Cabin, Texas;

**WHEREAS**, it is further necessary to provide fines, penalties, fees and costs involved in the regulation of "Special Events" in the City of Log Cabin, Texas;

**WHEREAS**, it is necessary to immediately adopt a "Special Events" ordinance to provide for the health, safety and welfare of the inhabitants of the City of Log Cabin, Texas;

**SECTION II. DEFINITIONS**

**"SPECIAL EVENT"** – Any event held in the City of Log Cabin that requires additional Police Officers, Maintenance Personnel, Park Attendants, etc. to maintain order and/or control; or any event deemed a "Special Event" by the City Council and/or Mayor of Log Cabin.

**SECTION III. AUTOMATIC ENACTMENT OF CITY ORDINANCE**

The City Council and/or the Mayor of the City of Log Cabin is hereby authorized and directed to implement the enactment of this ordinance upon approving a "Special Event" and/or determination that implementation is necessary to protect the public welfare and safety, and to prevent unnecessary expense to the City of Log Cabin.

**SECTION IV: APPLICATION OF CITY ORDINANCE**

The provisions of this Ordinance shall apply to all persons, firms, groups, organizations, corporations, residents and visitors to the City's park facilities, Red Barn, Boat Ramp, and/or any other City buildings or property, when an event is deemed a "Special Event".

**SECTION V. FEE SCHEDULE**

During events deemed "Special Events", the following fee schedule shall apply:

**VENDOR PERMIT FEE:** \$50 per permit, per Vendor, per event

**RED BARN RENTAL:** \$500 per day, with normal deposit

**RV SITES w/ utilities:** \$75 per night if reserved by the Thursday preceding the event (or at least 2 days prior to the Event if not held on the weekend);  
\$100 per night if reserved after.

**PRIMITIVE SITES:** \$35 per night if reserved by the Thursday preceding the event (or at least 2 days prior to the Event if not held on the weekend);  
\$50 per night if reserved after.

**PARKING:** \$5-\$10 per vehicle per day, depending on event.

**WALK-INS:** \$3 per Adult; \$1 for Kids 6 years of age and under

**REFUNDS:** NO REFUNDS WILL BE GIVEN ON ANY FEE'S LISTED IN THIS SECTION DURING "SPECIAL EVENTS".

**SECTION VI. RV PARK RESTRUCTURING**

During "Special Events", all camping spots with utilities will be available for RV's only; *No Tent Camping spots with utilities will be available.* Tent Camping will be primitive only, and additional primitive camping spots in the City Park may be designated during "Special Events".

**SECTION VII. PENALTY**

Any person, firm, corporation, agent or employee thereof who violates any of the provisions of this ordinance shall be guilty of a Class C misdemeanor and upon conviction thereof shall be fined not to exceed \$500 for each offense. Each day a violation is committed constitutes a separate offense.

This Ordinance is duly enacted by the City of Log Cabin, Texas pursuant to the general laws and Constitution of the State of Texas. This ordinance shall take effect after its passage and publication as required by law.
