## AFFIDAVIT FOR SEARCH WARRANT

STATE OF ARKANSAS COUNTY OF LONOKE SS.

TO ANY SHERIFF, CONSTABLE OR POLICE OFFICER IN THE STATE OF ARKANSAS:

Before the Court of the County of Lonoke, the undersigned being duly sworn deposes and says that he has reason to believe that the evidence is located at the residence of 108 Hamburg, in the City of Lonoke, in the County of Lonoke, State of Arkansas; further described as a single family two story dwelling having a grey shingle roof and a red/rust color brick exterior. This residence has at least two out buildings. One out building is attached by way of the carport of which the roof is adjoining. There is a building in the back yard that is dark in color and appears to be constructed of wood. There is a black U.S. Mail box in front of the residence displaying the numbers "108" and "Walls". The front door of the residence has a black cast iron door. There is now being concealed certain property; to wit: Nude photographs, black wig, pornographic books, pornographic magazines, pornographic tapes, sleeping bags, ponchos, alcohol, 45 Cal. Rifle, Automatic Weapons, Boy Scout Records, Tent, Pink Paint, Semen, Towels, Explosive Residue. This residence is further identified as being the residence of Charles A. Walls III.

The facts tending to establish the forgoing grounds for the issuance of a Search Warrant are as follows:

A. My name is Charles Peckat (hereafter referred to as the affiant) and I am a commissioned Law Enforcement Officer serving the City of Lonoke since July 7th, 1997, I also have 21 years Law Enforcement experience with the City of North Little Rock, Arkansas. On 8/1/97, a complaint of Rape and Sexual Misconduct was filed with the Lonoke Police Department. The Lonoke Police Department and the Arkansas State Police interviewed in excess of two victims. The victims stated that sexual activity took place with Charles A. Walls III while in the residence or on the property of 108 Hamburg. One victim stated to the affiant that he was in the shed with Charles A. Walls III on 4/13/97, where Charles A. Walls III gave him a bottle of Peppermint Schnapps Liquor. He also stated that Charles A. Walls III showed him a photograph of a nude female that was hidden near the west window. This victim is 16 years of age, and stated that Charles A. Walls III engaged in sexual activity with him in the residence and out buildings of 108 Hamburg. Another victim stated that between June 15, 1997, and July 4, 1997, he was in one of the out buildings located at 108 Hamburg, Lonoke, Arkansas, and observed a nude photograph of a female. He also stated that he had been in the out building several times between 1/1/97 and 7/4/97 and observed pornographic material. This victim was 17 years of age between 1/1/97 and 7/4/97, and stated that Charles A. Walls III did not stop approaching him and performing oral sex on him. He said that he had sexual relations with Charles A. Walls III in the residence and out buildings located at 108 Hamburg St. Lonoke, Arkansas, during this period of time, but he can not give the exact dates. The victim stated that the sexual activity stopped after his 18th Birthday,

- B. The victims relating to this search warrant were 16 and 17 years of age, prior to July 4, 1997. Both of these victims are still in High School, and one is involved in school activities. Both of these victims have been involved in Scouting for many years, and both obtained the position of Eagle Scout. Neither victim shows any criminal history and both should be considered reliable.
- C. The Victims stated that Charles A. Walls III stored explosives in the brown shed in his back yard, located at 108 Hamburg Street, Lonoke, Arkansas. This explosive material was used to blow up beaver dams at the Walls Farm and to excite these young victims into going to the farm.
- D. On 10/23/97, one of these victims made a drawing of one of the outbuildings. He pointed out locations within the building where sexual acts have taken place. He pointed out locations where we might find semen on the floor or workbenches.
- E. Both victims stated that they observed a photograph of a nude female in one of the outbuildings. They stated that Charles A. Walls III hid the photograph near the north west window and used it to excite them into engaging in sexual acts.
- F. The victims stated that they shot several guns owned by Charles A. Walls III. The affiant was advised that one of the outbuildings was used to work on these guns and to convert them into fully automatic weapons. These weapons were used to gain the trust of these young males and to entice them into go to the farm to shoot them. At least one victim was intimidated by a weapon that Charles A. Walls III was known to carry in his vehicle.
- G. A reliable third victim who will give testimony in this case revealed that some victims had been photographed from the waist down by Charles A. Walls III. These photographs were observed in a box in the garage during the early 1990's by one victim.
- H. Victims have stated that at least one outbuilding contains several pornographic books and magazines and VCR tapes. This material was given to the victims to excite them into engaging in the sexual acts. One victim pointed out locations of these items in an outbuilding, located at 108 Hamburg Street, Lonoke, Arkansas.
- I. One of the reliable victims stated that approximately (5) five months ago, he walked into the house of Charles a. Walls III, located at 108 Hamburg Street, and observed Charles A. Walls III performing oral sex on another male, while the male guest was siting in the reclining chair.
- J. One of the reliable victims stated that he has been involved in sexual acts with Charles A. Walls III, while sitting on the couch and love seat, located in the Living Room/Den of 108n Hamburg Street, Lonoke, Arkansas. He stated that the couch/love seat could have semen stains. He stated that the last incident he can remember id February, 1995.
- K. One victim stated that he has been in the residence of Charles A. Walls III several times between January 1, 1997, and July 4, 1997. He stated that he has engaged in sex acts with Charles A. Walls III several times during these dates, but can not give any exact dates at this time.

- L. Camping equipment stored at 108 Hamburg is some of the same camping equipment used on Scout outings. The tent, sleeping bag, and ground tarps are some of these items used on these camping trips. Sexual acts took place while Charles A. Walls III or his victims were on these items. They may contain semen or hair evidence.
- M. A Fourth reliable victim who will be a witness have stated that they have observed Charles A. Walls III dressed in a black and blond wig, while at his residence of 108 Hamburg Street, Lonoke, Arkansas.
- N. One Victim pointed out a towel shelf that should contain an orange, pink, and blue towel. He stated that Charles A. Walls III would use these towels to wipe himself after sexual acts.
- O. One victim completed a drawing of an outbuilding, and pointed out a cabinet in the garage that contained cigars. Charles A. Walls III would use these cigars to entice his young victims.
- P. On victim competed a drawing of an outbuilding showing a cabinet that contained the alcohol that Charles A. Walls III would hand out to young juveniles.
- Q. One victim completed a drawing showing the locations of possible semen in the attic of an outbuilding. He also stated that there were several pornographic books in the attic.
- R. One of the victims stated he had accompanied Charles A. Walls III, while using pink paint and poisonous chemicals at another Lonoke residence.

I therefore request that a Search and Seizure Warrant be issued for 108 Hamburg, Lonoke, Arkansas, and then seize any tarps, semen, body fluids, papers, books, photographs, guns, camping equipment, paint, towels, explosives residue, pornographic books, pornographic magazines, pornographic VCR tapes, black and blond wig, or any other item deemed as contraband. I further request that the Warrant include not only out buildings, as I have described, but also the residence and/or vehicles on the property.
