Presiding Commissioner, Kyle Carroll welcomed those in attendance and led all in prayer. The Pledge of Allegiance was then recited by all in attendance.

Collector/Treasurer, Jessica Lee advised patrons will have until May 31st to pay their oldest tax years. Payment may be made up to the time of the sale. However, payment received on or after June 1st must be for all years' delinquent and also must include any and all expenses of the sale. At that time, payment must be in the form of cash or a cashier's check only.

The Commission approved a monument to be placed near the building at the request of The Maysville Endowment Committee. Presiding Commissioner, Kyle Carroll will let Warren McElwain of the Maysville Endowment Committee know and what conditions need to be met before it can be placed.

Road & Bridge Supervisor, Bill Gray met with the Commission to discuss work around the County, equipment, roads that had high water and an update on the Commercial Driver's License process. Bill advised that Chris Franks has the properties he placed bids on completed.

Garry McFee of Howe & Company met with the Commission to have Presiding Commissioner, Kyle Carroll sign documents for the current BRO projects.

County Clerk, Melissa Meek discussed taking a tour of the Historical Society and the need for a commercial dehumidifier for the basement.
