Discussion of 2025 State Championships Tentative Schedules

Joey presented various athlete numbers by level for the 2024-2025 season, including the number of athletes registered in the tracking database, have competed at that level, and have already qualified for the level. These numbers are used to create tentative schedules for each of the State Championships.

The Compulsory state championship was presented first, with a proposed schedule. It was noted there were some errors in the calculations, so this discussion was tabled until the end of the meeting.

Next was a discussion of the number of athletes at the Level 6, 7, Xcel Silver, Platinum, Diamond, Sapphire State Championship on the weekend of March 28-20, 2025. The total number of athletes for this meet would cause the meet to need an extra day (Thursday), regardless of how the schedule was organized.

By moving the Sapphire athletes to the Level 8-10, Xcel Bronze, Gold State Championship on the weekend of March 21-23, 2025, this problem should be eliminated, and the competition should be able to be held in three days. The Sapphire athletes would be included in the first Level 8 session on Friday.

It was noted this change does have a major impact on these athletes and coaches, and should be communicated as soon as possible.

Tricha made a motion to move the Xcel Sapphire athletes to the Level 8-10, Xcel Bronze, Gold State Championship the weekend of March 21-23, 2025.
