### SHORT TERM RENTAL AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE SHORT TERM RENTAL ORDINANCE PERTAINING TO THE DEFINITION OF RENT OR RENTAL; THE DEFINITION OF ZONING ADMINISTRATOR; AND THE REGULATION OF SHORT-TERM RENTALS AND BED AND BREAKFAST OPERATIONS.

Section 1 of the Ordinance restates the definition of Rent or Rental.

Section 2 of the Ordinance defines Zoning Administrator.

Section 3 of the Ordinance adds Section 01-05 (k) regarding Short Term Rentals and bed and breakfast establishments.

Section 4 of the Ordinance provides for an effective date of the Ordinance.

# SHORT TERM RENTAL AMENDMENT ORDINANCE ORDINANCE NO. 226/9-2

AN ORDINANCE TO AMEND THE SHORT TERM RENTAL ORDINANCE PERTAINING TO THE DEFINITION OF RENT OR RENTAL; THE DEFINITION OF ZONING ADMINISTRATOR; AND THE REGULATION OF SHORT-TERM RENTALS AND BED AND BREAKFAST OPERATIONS.

THE TOWNSHIP OF CASCO, ALLEGAN COUNTY, MICHIGAN ORDAINS:

Section 1. <u>RENT OR RENTAL</u>. The definition of RENT or RENTAL in Section 01-02 of the Short Term Rental Ordinance shall be restated in its entirety as follows.

Rent or Rental — The permission, provision, or offering of possession or occupancy of a Single-Family Dwelling with some type of remuneration paid to the Owner for a period of time by a person who is not the Owner, pursuant to a written or verbal agreement.

Section 2. <u>ZONING ADMINISTRATOR</u>. The definition of ZONING ADMINISTRATOR in Section 01-02 of the Short Term Rental Ordinance shall be added in its entirety as follows.

Zoning Administrator – Shall include the Zoning Administrator designated under the Casco Township Zoning Ordinance, or such other person designated by the Township Board.

Section 3. <u>SHORT-TERM RENTALS – BED AND BREAKFAST ESTABLISHMENTS</u>. The Short-Term Rental Regulation in Section 01-05 of the Short Term Rental Ordinance shall be expanded by adding Section 01-05 (k) to state in its entirety as follows.

(k) Short-Term Rentals or bed and breakfast establishments. A Single-Family Dwelling used as a Short-Term Rental after May 15 of any year shall not thereafter be used as a bed and breakfast establishment before September 15 of that year. Likewise, a Single-Family Dwelling used as a bed and breakfast establishment after May 15 of any year shall not thereafter be used as a Short-Term Rental before September 15 of that year. In no event shall a Single-Family Dwelling be used as a Short-Term Rental and as a bed and breakfast establishment at the same time.

Section 4. <u>EFFECTIVE DATE</u>. This Ordinance was approved and adopted by the Township Board of the Township of Casco, Allegan County, Michigan, on <u>February 26</u>, 2019. This Ordinance shall be effective 30 days after publication of its contents or a summary of its contents in a local newspaper of general circulation in the Township.
