Cell Phone Use While Driving in Texas

DID YOU KNOW THIS??

As of 2014, there was no statewide ban against cell phone use while driving in Texas. That includes texting and driving. With that being said, there are plenty of local areas that prohibit or limit the use of cell phone in the car. **BEWARE...**Various cities pass local legislation recently concerning use of electronic devices. Some of the various jurisdictions in Texas that have further restrictions on cell phone use while driving include the following: Arlington, Austin, Bedford, Bellaire, Brownsville, Conroe, Denton, El Paso, Galveston, Grand Prairie, Harlingen, Houston, Magnolia, McAllen, Mission, Missouri City, Mount Vernon, Nacogdoches, San Antonio, Stephenville, Tomball and Universal City. This is far from an exhaustive list, and the trend is towards more regulation rather than less. The following are the newest cities joining this trend.

AUSTIN: *(Bans ALL USES, except Hands-free)*

Austin is a hands-free city. A new City of Austin ordinance prohibits the use of all electronic hand-held devices while operating a vehicle or bicycle. To avoid fines up to \$500, put your phone away or consider using a hands-free system such as Bluetooth or headphones, or an affixed GPS system. Unless using a hands-free system such as Bluetooth or headphones, or a GPS system, use of portable devices while driving a car or operating a bike will be a citable offense beginning Jan. 1, 2015.

BEDFORD: *(Bans ALL USES, except Hands-free)*

On November 18, 2014 the Bedford City Council passed a new ordinance banning the use of electronic devices while driving. The City of Bedford joins only a handful of Texas cities that have instituted a ban on electronic device use in vehicles. Arlington and Grand Prairie passed similar ordinances. Electronic device use includes using cell phones in any capacity – texting, phone calls, internet browsing. The only electronic devices that may be used at any time in a moving vehicle are GPS navigation devices (dashboard mount or on-board systems). Cell phone calls may be placed using hands-free devices or in emergency situations.

DENTON: *(Bans ALL TEXTING, except Hands-free texting)*

The Denton City Council voted unanimously to outlaw texting and most usage of mobile phones with the exception of vocal conversation in the entire city excluding interstates and their service roads. The ban is similar to an ordinance in the City of Arlington banning all cellular phone activity aside from phone calls. Use of GPS services is allowed only if the cell phone is mounted to the dash board. Texting and all uses are allowed when the vehicle is stopped and out of the flow of traffic or if there is a life-threatening emergency.

GRAND PRAIRIE: *(Bans ALL TEXTING, except Hands-free texting)*

The Grand Prairie ordinance prohibits the use of a wireless device to send, read or write text messages or e-mails while driving. Texting or e-mailing is allowed ONLY if the driver is parked and out of the roadways. Drivers may still make and receive phone calls while driving, use the cell phone for navigation if it is *mounted* inside the vehicle and text or email in a hands-free mode.

Cell Phone Use While Driving in Texas (Cont'd.)

SAN ANTONIO: (*Bans ALL USES, except Hands-free*)

San Antonio, the second-largest city in Texas, has outlawed use of handheld cell phones, effective Jan. 1, 2015. The city joins Austin, whose ban on the wireless communications devices also goes into effect with the new year. San Antonio's ban comes with a fine of up to \$200 after a 30-day grace period. The city plans an education campaign dubbed "*Keep 'em on the Wheel, San Antonio.*" The city amended its current distracted driving ordinance, which outlaws cell phone use by drivers in school zones. Under the new San Antonio law, motorists are barred from holding the devices to make phone calls, text, use email, access the Internet, play games as well as "other use of the device." Unlike the Austin ordinance, drivers are barred from using smartphones and similar devices while temporarily stopped in traffic, as in at a red light.

STATE OF TEXAS:

SB 181 allows a motor vehicle operator the option of using a wireless communication device (such as a cell phone) to display motor vehicle financial responsibility (proof of insurance) information as evidence of financial responsibility. The display does not constitute effective consent for a law enforcement officer, or any other person, to access the contents of the wireless communication device except to view the financial responsibility information. *This bill is effective immediately.

Sec. 545.425. USE OF WIRELESS COMMUNICATION DEVICE; OFFENSE (a) In this section:

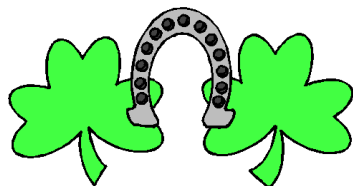
- (1) "Hands-free device" means speakerphone capability or a telephone attachment or other piece of equipment, regardless of whether permanently installed in the motor vehicle, that allows use of the wireless communication device without use of either of the operator's hands.
- (2) "Wireless communication device" means a device that uses a commercial mobile service, as defined by 47 U.S.C. Section 332.
