- BUDGET PREPARATIONS Evelyn mentioned to the board to notify her of any extra expenditures anticipated for next year as she is working on the budget. She will have it for review at next month's meeting.
- MILLER HOLLOW INTAKE STRUCTURE PROJECT A motion was made by Edward Shea to authorize the engineer to place the Miller Hollow Intake structure project out to bid, seconded by Wilbur Kelly. This has to be done to make the Miller Hollow source more stable for the future. Chet stated that Miller Hollow will need to be down for at least 30 days and that the Hazeltine source has improved since we fixed the leak. The remaining water will be from the Spangler well sources.
- PROPERTY ACQUISITION—Bill Barbin said that he is still working on property acquisition for Angellotto, Lamagna and Chordas properties. He stated that condemnation can be acquired in 60 days so he's not worried about the timeline.
- Simplify INSURANCE A motion was made by Wilbur Kelly to authorize the Chairman to approve an insurance policy for the lowest cost, seconded by Edward Shea. All in favor.
