1. Ordinance No. 1 of 2021

TITLE: AN ORDINANCE TO AUTHORIZE THE EXCHANGE OF SALE OF THE TOWN'S INTERESTS, LESS AND EXCEPT MINERAL INTERESTS, IN LOT 38, GOLDEN MEADOWS SUBDIVISION, FOR THE INTERESTS OF TALITHA MONROE AND RAQUITTA JAMISON IN LOT 89, GOLDEN MEADOWS SUBDIVISION, AND TO OTHERWISE PROVIDE WITH RESPECT THERETO

Town Clerk, Veronica Brown read the Ordinance by title and explained this approval would introduce and set the Ordinance for Public Hearing on Monday, April 19, 2021 prior to the Regular Session Meeting. There were no questions or concerns from the Board. A motion was made by Alderman Robinson, seconded by Alderman Doughty to approve the Regular Session Minutes. A motion was made by Alderman Robinson, seconded by Alderman Davis to approve the reappointment. The motion was carried by unanimous voice vote

3. Discussion on property standards

Mayor Frank introduced Glen Mazier and he explained the current process and procedures of Property Standards. There was discussion from the Board on how to help Glen be more effective in his job and be more aggressive in his job performance. Town Clerk, Veronica Brown explained that there is no money currently budgeted for Property Standards, however the Mayor will be allocating funds in the upcoming budget.

Mr. Dan McGuire, greenwood resident was in favor on being more tough in the administration of the Property Standards code and he also advised that the town send a letter out to the residents and advise them that the code will be enforced according to the current Ordinance.

Alderman Robinson questioned if we were utilizing all the resources that was available to the town and then the discussion of the budget was mentioned

The general opinion of the members present Board and Public that Property Standard Citations should be issued more frequently and Mayor's Court should be utilized more for enforcing the code
