Elections inspectors were approved at the Election Commission meeting and the public accuracy test was held Monday, February 12, 5 pm. and all went well.

#### **New Business:**

- Fire Update Statement Fire Department update. Assistant Chief Grinnell has been suspended indefinitely from his Assistant Chief role while we continue with our investigation. I have been appointed as the Secretary/Treasurer of the Fire Board. Mark Helt, Danny Chapko, and Jason Bowen have rejoined the fire department. The board is creating a Budget Committee and will start reviewing the budget for the 2024-25 year. A board member has started to attend the weekly Fire Department meetings. The fire and rescue personnel appreciate the board's involvement. It was moved by Ryan Boots and supported by Robert Ladiski to approve the fire run billings as they are received. Approved.
- Ambulance Update Resolution for the new ambulance were received from all municipalities as was the 2024-25 budget.
- Budget Discussion Increase in the assessor fee from \$18,000 to \$18,900. And the Friendship Park care taker Don Cramer is requesting an increase of \$200 for services rendered.
- Millage Request The EMS and Road millages are up for renewal; ballot language must be submitted by May 14<sup>th</sup>. Consider ¼ mill road and ¼ mill for EMS.
- Road Commission Annual Meeting is slated for March 13, 8 am.

**County Commissioner:** Val Vail-Shirey – Work group meetings February 15, 2024, 9 am; Greenbush Solar Project extension was addressed by Zoning and Planning February 8, 2024, it was ill prepared, laughable ask. Unanimously denied. Will now be forwarded to the full Commission. At the February 20 meeting will address the Solar and Wind ordinance. Q and A followed.
