CORONAVIRUS/COVID-19 IN CLASSROOM AND BEHIND-THE-WHEEL LESSONS
ASSUMPTION OF RISK, RELEASE, WAIVER AND DISCHARGE

Read the document carefully before signing. Signing of the document is required for the student to participate in any Accurate Driving LLC program, event, or activity.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. It is believed that an asymptomatic individual can be infected with and transmit COVID-19.

Accurate Driving LLC, has put in place preventative measures recommended by the State of Hawaii to reduce the spread of COVID-19, however, Accurate Driving LLC, cannot guarantee that you, your child, your spouse, your legal representatives, heirs, and assigns or anyone else will not become exposed to or infected with COVID-19 as a result of participating in any Accurate Driving LLC program, event or activity. Participation in an Accurate Driving LLC program, event or activity could increase the risk of contracting COVID-19.

NOW, THEREFORE, in consideration of being permitted to participate in programs, events and/or activities offered by Accurate Driving LLC, I understand, acknowledge, and agree to the following:

1. I have independently evaluated and reviewed the risk of being exposed to or infected with COVID-19 and have determined to participate in Accurate Driving LLC programs, events, and/or activities with full knowledge and acceptance of the risk.
2. I fully understand these risks, for myself, my child, my spouse, my legal representatives, heirs, and assigns, hereby agree to assume full responsibility and liability for the risk of bodily injury, illness, permanent disability, and/or death which may result from exposure to or infection with COVID-19 before, during, or after participating in an Accurate Driving LLC program, event, or activity.
3. I, for myself, my child, my spouse, my legal representatives, heirs and assigns, hereby waive, release, and discharge Accurate Driving LLC, its employees, attorneys and agents from any and all liability to me, my child, my spouse, my legal representatives, heirs and assigns, for any and all losses or damages resulting from bodily injury, illness, permanent disability, and/or death, whether caused by negligence of Accurate Driving LLC or its employees, attorneys and agents or otherwise, which claims, losses, and demands arise during or result directly or indirectly from exposure to or infections with COVID-19 before, during or after participating in an Accurate Driving LLC program, event or activity.
4. I also acknowledge that in the event the State or local health department issues a mandatory "Stay at Home" order, or mandates the closure of certain programs and/or facilities, Students will be entitled to make-up program, event or activity.
5. I also acknowledge that in the event the State or local health department issues a mandatory "Stay at Home" order or mandates the closure of certain programs and/or facilities, refunds will NOT be issued.
6. I also agree to the following conditions for my teen (the student) to attend any Accurate Driving LLC programs, events, and/or activities that are conducted at the Accurate Driving LLC classroom.
 - a. If your teen has a serious chronic medical condition that potentially compromises their immune system, they should not attend a driver education class until covid-19 is under control.
 - b. The student will bring their own supply of hand sanitizer. They will use the sanitizer every time before entering the classroom.
 - c. The student will bring their own face mask and wear the face mask during the entire duration of the class whether in or out of the classroom.
 - d. The student will not get closer than 6 feet of another student.
 - e. If the student has an allergy; the symptoms must be under control. Any student with sniffles, runny nose, cough will be sent home and need to make-up the missed session.
 - f. The student will delay attending any Accurate Driving LLC programs, events, and/or activities that are conducted at the Accurate Driving LLC classroom for 14 days if they have:
 - i. Attended a gathering of people who did not wear face masks and keep distances of 6 feet between each other.
 - ii. Been exposed to any who showed symptoms of a flu or cold
 - iii. Been exposed to someone diagnosed with Covid-19.
 - iv. Any symptoms of a cold or flu.
