At your nomination hearing, March 22, 2022, you committed to require contractors to report valid *measures of cost, schedule, and technical performance* and to adopt digital engineering (DE) as the source of those measures (now called outcome-based metrics). I had submitted the following questions to the SASC which were used at the hearing.

I brought these unfinished tasks to your attention in the letter, same subject, dated July 17, 2024. That letter concluded:

"Please implement your commitments during this term. There is no assurance that a possible Trump administration will implement the (relevant) Project 2025 initiatives."

As of today, you have not met the commitment in response to Question 51. Also, there has not been successful adoption of DE to feed the right cost, schedule, performance and risk data to our

acquisition decision makers. During the Presidential Transition, please emphasize the importance of this unfinished business to your successor.
