ORDINANCE NO. 2 - 1963

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE TOWN OF CLOVERDALE, INDIANA

SECTION I. Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana to-wit: Clark's Place Addition to the Town of Cloverdale Indiana as laid out, platted and recorded in Plat Book #3, Page #132 in the Putnam County Recorder's office, Lots #5,6,7,8,9,10, 11, and 12 of the Morrison and Martin Addition to the Town of Cloverdale, Indiana as laid out, platted and recorded in Plat Book #3, Page #126 in the Putnam County Recorder's Office.

Also the following described real estate in Putnam County, Indiana to-wit: Situate in the State of Indiana, County of Putnam and being a part of the Southwest quarter of Section 6, Township 12 North, Range 3 West of the second Principal Meridian more particularly described to-wit: Beginning at a point on the West line of Section 6, Township 12 North, Range 3 West, which point is 980 feet South of the Northwest corner of the Southwest quarter of said Section 6 and on the present South Corporation line of the Town of Cloverdale, the said point of beginning being in the centerline of Doe Creek; thence North with said Section line and with the said Corporation line 790 feet; thence leaving said Section line and with the said Corporation line East 200 feet to the center of Indiana State Road 43; thence North 160 feet; thence East 250 feet to the West line of Morris First Addition to the Town of Cloverdale; thence Southeast 830 feet to the Southwest corner of Morris Second Addition to the Town of Cloverdale; thence Northeasterly 190 feet with the South line of said Second Addition to the center line of a public road; thence North 30 degrees 40 minutes West with the centerline of said road 220 feet; thence North 59 degrees 20 minutes East 155 feet to the Southeast corner of the present Corporation line of the Town of Cloverdale; thence leaving said Corporation line South 30 degrees 40 minutes East 517 feet; thence North 86 degrees West 190 feet to the centerline of a public road; thence South 30 degrees 40 minutes East 210 feet with the center line of said road to the centerline of the bridge over Doe Creek; thence westerly with the meanders of the centerline of said creek 1180 feet to the point of beginning. Containing 19.8 acres or more or less. The above described real estate is recorded in Plat Book # - 31, Page # 479.

SECTION II: That this ordinance shall be in full force and effect from and after it's passage and legal publication thereof according to law.
