Supervisor Ferguson and Trustee Ferguson met with Denise Russman from Fulton Township regarding their Planning and Zoning Board. They reported Fulton Township had Pete Preston draft a Master Plan for their Township, at a cost of approximately \$10,000. It costs approximately \$640 per year for Fulton Township to fund their Planning Commission. Supervisor Ferguson tabled discussion on a planning commission, citing further investigation being needed to proceed.

Supervisor Ferguson motioned to set limits for poverty exemption at the levels suggested by the State Tax Commission (STC) in Bulletin No. 14 of 2013. The STC guideline suggestions as follows:
