Sealed Bids, for furnishing all materials, labor, tools, equipment, and appurtenances necessary for approximately 2.5 miles of recycled asphaltic concrete resurfacing on **UPPER BELL RD AND UPPER HIGH TOWER RD** will be received by the Owner at the **Temporary** County Commissioners Office located at 900 N Main Street, Hiawassee, Georgia 30546, until 9:00 a.m., local time, on April 18, 2023, and then at said address read aloud at the regular county meeting to be held on April 18, 2023 at 5:30pm.

The Project consists of the following major elements:

**Approximately 2.5 miles of recycled asphaltic concrete resurfacing on UPPER BELL RD AND UPPER HIGHTOWER RD.**
