Three young people on bicycles rode through our neighborhood at 4:00AM on a weeknight looking for crimes of opportunity. Cars parked outside are like candy to these thieves. They proceeded to open every unlocked car door and ransack every unlocked car. Notably they were looking for easy valuables left unattended, shopping bags, purses, briefcases, etc. They were also looking for garage door openers to get into garages during the night or to return at a later time when they think no one is home. We have them on video on all four of our streets! Gwinnett County Police say we need to straighten out our garages so we can get our cars inside where possible and not have any cars parked in the street. Also when talking with the Gwinnett Burglary Unit they stated that an unkempt neighborhood was attractive to criminals. Lawns poorly maintained, junk and weeds in the yards, and grass growing across the sidewalks and driveways are all attractors for crimes of opportunity. Trash cans left outside indicate no one is at home. This neighborhood has covenants that cover all of these issues. Our covenants are to keep property values high but more importantly to protect our homeowners. Our video has provided a good photo of the thieves and there is currently a BOLO issued on them. Hopefully someone will recognize them and they will be stopped from continuing to do this. But until then, let's try to keep them off of our streets by maintaining our homes and keeping valuables out of site and car doors locked.
