# In Loving Memory

On August 24 I was in the basement starting to load the washer and the kids were all out to potty after dinner. Suddenly there was a single voice screaming and yelping in pain. I raced up the stairs and out the back door to find Sky standing and staring at a dark gray female on her back thrashing her legs in the air, Pinky and Honey shot past and I knew it was Mud Lily. She had fallen and the left side of her head was at a strange angle against the fence and her body. I yelled at Sky to get away – he shot to the far corner of the pen and stayed there. Mud got up and blood was pouring from her mouth. I tried to get a hold of her to see what her injury was and she darted away to another corner. I ordered all the kids to “STAY” and raced inside for wet and dry paper towels. Once back out Mud let me approach and started cleaning up the blood, which I thought was due to a lost tooth – her last tooth. Surprisingly it was still there. It took quite some time for the bleeding to stop and then she seemed fine. She came in and settled in for a bit. It was at this point that I started to look to see who else had blood on them and it was Honey – she had a large spot in the middle of her back, yet no injury, so it had to have been Mud’s blood. In a few hours I noticed that every time she moved she yelped and finally around 9:35 pm we were on our way to the emergency vet in Madison because she hadn’t had any water since dinner which was around 4:15.

Without a sedative they could only see that there was a bruise under her tongue, she wouldn’t let anyone open her mouth. So they took her back to the procedure area and gave her a sedative. She had a reaction to the sedative that caused her to thrash about and toss her head and she started to scream and yelp again. I was in the lobby and bawling because my baby girl was in agony and I wasn’t there to hold her. Finally after about 20 minutes of her screaming and thrashing they got an IV line in and gave her anesthesia. By 11:20 I knew her left jaw was broken. Then it was my turn to cry and howl – they wanted to send her to the west side for emergency surgery to wire her jaw shut and put a feeding tube in, she would be in isolation for 6 weeks minimum and if it didn’t mend I would have to put her to sleep.

By 11:30 I asked to see her so that I could tell her “good-bye”. By 11:50 she was gone. Mud Lily was my treasure – she and I had a lot of “firsts” together. I came home empty handed and Cloud hung his head.

Cloud and I cried for an hour.

The next day I realized that Sky and Honey were absolutely lost without their mother. Pinky has no one to shadow throughout the day. Cloud mopes and cries.

We are all lost and sad without Mud Lily. She was 13.5 years old.
