## From the Secretary's Desk

Spring has also brought forth some changes that we all need to be aware of. In the recent Republican proposed budget they slipped in a little surprise for postal and federal employees that would make TSP Contributions worthless. To save \$32 billion over 10 years, House Republicans propose changing the fund's interest-rate calculation, because, the resolution says, "those who participate in the G Fund are rewarded with a long-term rate on what is essentially a short-term security." The fund's current annualized interest rate is 1.88 percent. Adopting the House plan would result in a precipitous interest-rate drop to an annualized 0.01 percent, according to the TSP. This little surprise along with the HR Concurrent 27 needs to be watched closely.

It is that time of year once again for the annual spring district meetings. I hope you are making plans to attend and participate in yours. The district officers spend their free time planning these meetings on your behalf. Your attendance would be appreciated by them. If you have a Resolution that you would like to present this will be the place to present it.

Due to limitations of space in this paper the new member list could not be included. However; the list will be printed in future editions as space permits. Since March 1st, I have processed 82 membership applications and our membership has only increased by 35 since February 28th. ### **House Concurrent Resolution 27**

Not much going on in Congress at this time as far as Postal Legislation but read on.

However as federal employees and postal employees, it appears to me that, we are being attacked from all sides. Benefits that we have fought to attain through PAC, NARFE, and Union Negotiations through the past many years are in jeopardy.

The House in the last week of March voted on a fiscal year 2016 Budget Resolution namely House Concurrent Resolution 27. The Resolution is seeking \$318 Billion in cuts to earned pay and benefits of federal and postal employees and retirees.

Some of the items are: increasing feder-

al retirees share of their health insurance premiums they pay, increasing the employee's share of premiums paid into Federal Employees Health Benefits Program (FEHBP) for all current federal employees and possibly totally eliminating the Federal Employees Retirement system (FERS) for new employees. Also the budget proposal makes reference to changes to the frequency and type of mail delivery.

The Senate will vote on their budget bill, Senate Concurrent Resolution 11; then the leadership of both the House and the Senate will meet and attempt to combine both bills eventually. Presenting a "Budget Reconciliation Bill" to both House and the Senate and then to the President.

Also, there is a bill that has been introduced by Republican Bruce Westerman (R-Arkansas), which would change the federal employee's calculations for retirement from the highest 3 years to the average of their high 5 years. If passed, this legislation would go into effective January 1, 2017 and according to the Congressional Budget Office, this could save \$3.1 Billion dollars over a 10 year period.

This is not the first time this item has come up and because as it is written it applies to all members of Congress and their Staffs.

This could be a long battle.

There is one new bill, House Resolution 973. It is a new bill but the intent of the bill is something that we have been fighting for

many years. The bill, introduced by Republican Rodney Davis (R-Illinois) is asking for the repeal of Government Pension Offset (GPO) and Windfall Elimination Provision (WEP). Both GPO and WEP deal with retirees. GPO prevents retirees who receive a government annuity based on work in non-Social Security covered employment from collecting full Social Security benefits based on their spouse's work. WEP greatly reduced the Social Security benefit who worked in a Social Security covered employment and who also receive an annuity based on their non-Social Security-covered government jobs. In common language, the government calls it "Double Dipping" but we believe if an individual worked two or more different jobs during their lifetime; they deserve both benefits.

Now is the time to put the "Grass Roots" Program to work. We need to contact our Representative and Senators and let them know our concerns.
