Summer meals = Free meal. The meals have to be dispersed in the effected zone. The USDA does not get involved. There is no reimbursement program.

- -<u>Tony Costa:</u> We need a board organized for food collection. Ideas raised: Summer meals, food drives, marina, sponsor a child, events, Friday nights/work meal
- -<u>Elizabeth Carpenter</u>: We have a dire need for food/medical assistance in Westbrook. There will be liability issues serving a meal. Ed Gales has a surplus from his community garden program.
- <u>-Jim Crawford</u>: The backpack program should be implemented during the summer months.
- -Patty Dowling: Sponsor a child anonymously.
