Greg Kaschinske joined Jessiffany Canine Services in 2019. He spent 16 years with the Columbia County Sheriff's Department. He has court room experience as well as having been a sniper and on Emergency response and dive teams. He is Kennel Master, Trainer and Consultant with Jessifanny Canine Services. I've met with Greg and he has graciously consented to do a program on some of the skills and requirements that officers and their canine partner must go through. You should plan on seeing some training techniques. Greg also trains dogs for hunting and obedience.

When I've been in the school building Jessiffany purchased, it is amazing to me (the untrained person) that the halls have backpacks, jackets, etc. hanging on the coat hooks in the hall. The class rooms are ever-changing scenarios of possible situations officers and their K9 partners may experience. Vehicles are in the parking lot that are used for training and testing. I see law enforcement K9 Unit vehicles from many city and county departments training.

Iessiffany also trains and provides dogs as part of 24/7 Battle Buddy canines to assist wounded military Veterans who have served in Iraq and Afghanistan. They work alongside Troops First Foundation in selecting the right dog for the right soldier.

I am looking forward to see and hear what Greg has in store for us.

Obedience Fix n' Go Option

By AKC Companion Events Department on March 2, 2021

Effective April 1, 2021, the following pilot program is approved to begin:

Chapter 2 Section 27. Training and Handling in the Ring. When a handler is using excessive verbal commands, this could indicate the dog is not under control and is not working with the handler willingly. The judge must determine if this dog should be released for a lack of control. The handler is not allowed to correct or discipline a dog and will be released from the ring.

When the dog's performance does not meet the handler's expectation, the handler may choose to use a "Fix n' Go" option once, which allows the exhibitor to immediately reattempt a single individual exercise. This allows the team to reattempt that one exercise, and then leave the ring. In a two-part exercise, the handler may choose only one part to reattempt. It is the handler's responsibility to tell the judge they are choosing to "Fix n' Go." Using the Fix n' Go option will result in a non-qualifying score (NQ). The handler may begin the reattempt from the start or at any point during the exercise. The judge will call the orders for the reattempted exercise as normal. If a jump needs to be reset, it will be set to the original height.

The handler may choose to help the dog through the Fix n' Go exercise. Helping the dog may be accomplished using verbal encouragement, including additional commands and praise, and/or approaching the dog in a friendly/positive manner without touching the dog.

Harsh verbal and /or physical corrections will not be tolerated. If there is any determination of harshness by the judge, the handler will be immediately released from the ring.

Spectators form their opinion of the sport through seeing the action of the handler and the dog. Care must be taken to avoid any action that might reflect poorly on the sport. If you have concerns, questions or feedback please write obedience@akc.org

Common Questions:

- → How should the judge's book be marked? The exercise is marked "NQ." The Judges' Guidelines, Chapter 5, page 124, "If a handler leaves the ring before completing the exercises, write "HLR" (Handler Left Ring) then carry an "NQ" in the "Total Score" box.
- → If the dog takes off running during the heel free, and the handler asks to start over, what should the judge do? The judge should release the team because the dog is not under control and working willingly with it's handler.
