RESOLUTION NO: SL-11-2022

TITLE: CORONAVIRUS CAPITAL PROJECTS FUND FROM US TREASURY APPLICATION FOR LIBRARY PROJECT

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council; and

WHEREAS, in accordance with Article II, Section I (b), to represent the Summit Lake Paiute Council in negotiations with Federal, State and local governments, and other corporations, associations, partnerships or individuals, in matters of welfare, education, recreation, and social services; and

WHEREAS, the Summit Lake Paiute Council is authorized pursuant to the Articles of Association of the Summit Lake Paiute Tribe, Article II, Section I (j), to determine their own rules of procedure; and (k), to take such actions as are necessary to carry into effect any of the foregoing duties; and

WHEREAS, the Summit Lake Paiute Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and

WHEREAS, the American Rescue Plan Act (ARPA) through the US Treasury appropriated funding for Tribal governments for Capital Projects; and

WHEREAS, the Tribe intends to enlarge the library services by purchasing additional books and adding laptop computers to be checked out by tribal members 13 years of age or older; and

WHEREAS, the Summit Lake Paiute Tribe of Nevada is requesting \$167,504.00 funding for a “Library Project” for the Tribal members and families; and

NOW THEREFORE BE IT RESOLVED, the Tribal Council of the Summit Lake Paiute Tribe does hereby submit Resolution SL-11-2022 to accept all allocated and supplemental funding allocated under the American Rescue Plan Act of 2021, US Treasury, Coronavirus Capital Projects Fund Awards for Tribal Governments.
