MAYOR'S LETTER

As this goes to press, the town is getting ready for the Fall Arts and Crafts Show on September 28th and 29th. Hopefully many of you were able to attend the show and patronize its vendors. As I always try to remind everyone, the fall and spring shows are our primary source of funding for town capital projects and special initiatives, and I want to especially thank Pat Thomas, Candie Best, Sheldon Levi, Bucky Brill, and all the rest of the town staff and volunteers who help put it together.

A number of special events will occur in October, many of them Halloween-themed. On Sunday, October 6, from 11:00 – 4:00, the Business Guild of Occoquan will sponsor an *Occoquan History Hunt*. Entry sheets will be available at businesses displaying orange balloons on the day of the event. Throughout the month the Guild will also reprise its *Haunting of Occoquan* event – participating businesses will display life-size Halloween figures with whom visitors can have their photographs taken. Additional business owners are also working together to make Occoquan look like a Halloween town as we approach the end of the month. On Saturday, October 26, more than twenty business owners are sponsoring a Halloween Parade with prizes for the best children and adult costumes. The parade will start underneath the Route 123 bridge and proceed to the cul-de-sac at the end of Mill Street. Everyone in costume is welcome in the parade; participants should gather no later than 10:30 a.m. at the parking lot underneath the Route 123 bridge.

Other events cover a diversity of subjects. On October 4, at approximately 4:00 p.m., the town will welcome two Army veterans who are traveling across the country from Washington State to Washington, D.C. on a tandem bicycle. As a stop on the Comfort for America's Uniformed Services (CAUSE's) inaugural "Warrior Ride" to raise awareness for PTSD, TBI, and service injuries, the town will be hosting the pair at Mamie Davis Park with a brief ceremony and free hot dogs and hamburgers. Town residents, business owners, and visitors are all invited. The next day, on October 5, from 10:00 to 4:00, Sentara Hospital will have a mobile mammogram vehicle in town. Additional events include the fall Friends of the Occoquan clean-up, as well as visits from several travel writers sponsored by Discover Prince William & Manassas. These visitors are all an important part of the Occoquan community, who we hope will return often in the future, so please extend them every courtesy and help make their visit an enjoyable one. ARB— Did You Know

When decorating for the holidays, Occoquan appears even more charming and appealing to everyone, especially shoppers. The merchants in Town always make jaws drop and eyes pop with their outstanding displays and decorations. The residents appreciate the extra work they do to make Occoquan a wonderland. Please be reminded that these types of displays, which normally begin in October, are not considered permanent and cannot remain longer than 30 days from the original installation date. The only exception to this rule is during the Winter Holiday season which begins on November 1 and ends on January 15. Let's try and keep the jack-o-lanterns, turkeys, and Santa's elves slightly separate. In addition, please note that generic or non-holiday-specific strings of colored lights outlining property lines, sales areas or any portion of a structure are not allowed except during the Winter Holiday season.
