ELIGIBILITY: Players must have a **USGA Handicap Index of 12.5** or lower for this event. Players must be current 2019 members of the BCGA and either a resident of Berks County, a current member of a BCGA Member Club or a Past Champion of any BCGA Event.

ENTRY EXEMPTIONS: See the 'Player Entry Exemption' policy for explanation and listing of exemptions.

FIELD LIMIT: 88 Players

FORMAT:

Qualifying Round - 18 holes of stroke play.

Low 32 players advance to match play rounds in two flights of 16 players each (Championship & 1st Flight). A 'Sudden Death' format will be used to determine the match play field in both flights. This will immediately follow the conclusion of play on Friday.

PRIZES: Champion in both flights and top place finishers

TEE TIME PREFERENCE: Early or Late as determined by entries

Contestants will be notified of starting time.
