President's Corner

Greetings:

I trust you all are enjoying an early Spring. The weather here in North Carolina is exhilarating. As I get older it seems I enjoy the simple things in life. As most of you know I was diagnosed with Cancer just after our last reunion in Washington DC. I've completed six chemotherapy treatments and will start Bone Marrow Transplant next month to combat this disease. My wife and I are confident that these treatments will eradicate the infection and we will be able to enjoy your company for many years to come. I'll keep you posted as to my recovery and plan to see all of you in St Louis next September.

I'll ask again that each of you submit a two page biography of your time in Vietnam with the Aerial Rocket Artillery. Your legacy needs to be recorded for us and your family as a record of your patriotism and service to this wonderful country. I need to explain to you how your efforts as Artillery men affected me.

During the Vietnam conflict, we soldiers were shuffled into units as DEROS and casualty short falls were created. For most of us, it was luck of the draw as to what unit you were assigned upon arrival in Vietnam. For myself, in February 1969, I was initially sent to Cam Ranh Bay anticipating an assignment in the Northern half of the country somewhere in I or II Corps. After in processing as a new WO1 Cobra pilot, I was sent to the southern most Army Airfield in the Delta to fly UH-1B model Gunships. As with most units, it was full of inspiring young men, ready to do their duty in combat operations. I enjoyed the comradery and excitement of the unit but was disappointed with the Vietnamese Army's treatment of their own civilians. Our aviation company supported the ARVN's tactical sweeps throughout IV Corps, but it seemed we conducted more pillage raids through the civilian villages than combat operations against the VC and NVA.

I found out that if I extended my tour of duty that I could request a transfer to another unit in country, so I initiated the paper work and started to explore what assignments would be fulfilling. Even in the Delta, the exploits of the other aviation units were discussed and memorialized so I considered a CAV assignment, or an Attack Helicopter Company, but the theme that struck true to my heart was the admiration of the US Army 1 st Cavalry Grunts to a unit known as "Blue Max"! When ever they were in peril, they knew they could call for close support from the Division's Aerial Rocket Artillery. When my extension was approved at the end of December 1969, I departed the Delta and transferred to the 1st Cav Division in III Corps. The Division G-1 wanted me in the 1st/9th Cavalry Squadron, but I managed to talk my way out of that assignment and was eventually posted to Charlie Battery, 2/20 ARA Battalion stationed at Quan Loi, just south of the Cambodian border. It was a fulfilling and satisfying assignment being on call with a two minute scramble ready to support 1st Cav "grunts" in close combat. On the first of May, 1970 the Division deployed into Cambodia to interdict the NVA supply lines and destroy their ammunition supply dumps. There was a lot of flying and close rocket shooting to provide cover for our illustrious Grunts assigned to this mission. My point in this narrative is to let you know it was your efforts and skills that created the battle harden image and history of the Aerial Rocket Artillery. This rectitude is what lured me into becoming a small part of the ARA combat team. It's because of your efforts and notoriety that I became an Aerial Rocket Artillery man. Now it's my turn to salute each one of you and stand proudly with our ARA heritage!

On the Wednesday, registration/checking will start the day and conclude with a welcome pizza dinner in the hospitality room (\$10 a person) at the hotel starting at 6:30 pm. On Thursday and Friday you are on your own for activities with some suggested, outlined activities below. On Saturday morning, we will hold business meetings between 10:00 AM to 12:00 noon. The afternoon is free time. The Farewell Banquet will be at the Hotel at 6:30 PM. (\$57 a person). This will be a fun filled week in St Louis, Missouri.

The St Louis Lambert International Airport is 12 minutes away from the hotel. The hotel runs a shuttle on the half hour, to and from hotel; contact hotel if you wish to use their shuttle to come or go, or to get to the Metro.

It has always been a feature of the ARA reunions to have tours, trips, and entertainments as a part of the presentation. These elements have always been well received and appreciated – although often expensive and requiring commercial transportation. This year, our host, the Board, has studied several factors and determined what might be a more suitable approach to renewing old friendships, enjoying a select site and avoiding undue expenses.

Factors:

The prime purpose of reunion is to see friends and relive experiences from the days of our youth. Perhaps we are getting forgetful and retell the same war stories, but everyone seems to enjoy them and the camaraderie is priceless. The war lasted long enough that each of us lived and labored in what seems a different time zone (and some were given second and third[?] opportunities? One remembers our brothers, Jim Cornfoot and Jim Giles who saw the inevitable and wanted to make one more reunion with friends while they could.

We are an aging population, often with disabilities or limitations which impacts on our ability to take part in certain activities. Fortunately, most of us are still able to get around and enjoy life, but it is getting harder for all of us. Time is a relentless foe of all humanity, and we, of the unique unit that we were represent, are slowly running out of the vigor of our youth and years allotted to us (especially those who were a little older then) when life seemed an endless adventure. Reunions are not road races. They are times for fellowship and reflection.

There are some who want to see "new frontiers" and crave adventure, for whom venues are necessary, and we owe it to them to make them available. It has always been a concern of the Board that the cost of the reunion may be a deterrent to some of our friends. One of the major costs has always been bus transportation, and in the light of our current inflation, is even more so. With the shrinkage in our population comes the concurrent shrinkage in participants and these reunions require minimums or result in penalties for falling short. Lately, we have had difficulty maintaining our minimums and filling our room quotas. Diminishing cost may serve to increase participation.

For the above factors, it is the Board's recommendation that we schedule a hotel as affordable as possible in a major city, a welcome buffet and farewell dinner, and opportunities for self-guided or small group gatherings for everything in between.

The Sheraton Plaza Tower/ Lakeside Chalet is large complex, fully equipped, housing many venues and restaurants, providing all one needs for a relaxed and enjoyable time.

Indoor/outdoor pool, sauna, exercise room and complimentary access to the Westport Fitness Center, in-house restaurant, lounge, and business center – all on the property.

Surrounding are 10 restaurants and entertainment establishments – Backstreet Jazz and Blues, Drunken Fish (Sushi), Jovick Subs (Deli), Funny Bone Comedy Club, Fuzzy's Tacos, Kobe Japanese Grill, McDonalds, Hats N Things Clothes), Starbucks, Panera, Trainwreck Saloon (old cowboy style), Westport Social Club, and Westport Playhouse. ATTRACTIONS FOR THE ADVENTUROUS

The Gateway Arch/Riverboat Cruises (314-982-1545) are probably the premier sights in the area. A memorial to the westward expansion of the USA, located in Gateway National Park on the Mississippi River, it offers a stunning view of St. Louis. The offerings include the Arch, with a tour of a museum (dealing with the history of the area and the westward expansion) and a tram ride to the observation deck. Lunch can be obtained from the Arch café or on a one hour cruise on a Mississippi paddle-wheeler. Parking can be gotten on the levee, if the river is not flooding, but is more certain at Busch Stadium for a fee. PARKING MAY BE PROBLEMATIC ON DAYS WHEN THE CARDINALS ARE PLAYING AT HOME. [September 19-21, 2023]. Accessiblle by Metro Link 8th & Pine station (about one hour)

NOTE: The tram is the only way to the top, the cars are 5ft X5 ft, at about 2/3 to the way up passengers must exit and climb 96 steps to the observation platform. Wheelchairs and scooters are PROHIBITED, and the time to look and take pictures is about 15 minutes before having to return to the tram for the return trip. Use of any other stairs is prohibited save for emergency or maintenance.

Tram tickets and free museum -start at \$15 and tram ride lasts 45-60 minutes.

Documentary movie about the history of the Arch - \$7 and lasts 35 minutes.

One hour cruise - \$24 (A two-hour dinner cruise is also available in the evening on select Fridays and Saturdays).

All tickets are \$3 off for National Park passholders (must show pass). Some tickets have a senior discount.

A combination ticket for all three attractions is \$41 and is best purchased online. www.gatewayarch.com

Tours of he stadium are available and there is Stadium Village which is shop and restaurant venue next door. 

RUSS WARRINER RECOGNIZED FOR ONGOING SERVICE TO VETERANS



In February Rus Warriner was recognized with the National Grange Patriot's Award, by The Grange, of which he is a member, for his long-standing efforts to assist and aid veterans in their struggles with disability, benefits, and governmental red tape. In spite of his own personal losses (his wife Terri), and long-tern PTSD, Russ had persevered in organizing events for veterans and veteran organization, to include memory trips to Washington, DC and local displays to keep the veteran and his plight before the public.

He is an active officer in the Grange, VFW, and has written two books about his time in Vietnam and its aftermath.

Russ was the Founder and long-time President of the ARA.



COINS LEFT ON GRAVESTONE

According to Coin Update, regarding the tradition of leaving coins on the headstones of fallen service members in the United States traces back to the time of the Vietnam War. The reason that coins were placed on headstones instead of paying respect directly to the surviving family members at the time was to avoid the awkwardness of discussing the politically charged nature of the conflict in Vietnam. Each denomination means:

- · Cent: The simplest means of expressing respect to the fallen, a "penny" lets the service member's family know that someone visited their grave in the spirit of honoring their sacrifice.
- · Nickel: A nickel placed on the headstone of a fallen service member indicates that you trained at boot camp or endured basic training with the individual.
- · Dime: Leaving a dime on the service member's headstone means that you served with the fallen individual to some degree.
- · Quarter: One of the most significant coins to be left on a service member's headstone, a quarter means that you were present when the person was killed in action.
- · Challenge coin: If a challenge coin is found on the headstone of a fallen service member, it is seen as the highest form of respect paid by a comrade-in-arms.

Greater Love

It has been said that the friends we fought with against a common enemy are the closest we shall ever have. In my experience, this has proven true. The proximity of death and danger weld people into brothers for all time.

Literature and history are replete with examples of self-sacrifice for friends. Such as the legend of Damon and Pythias, two young philosophy students of the School of Pythagoras, famed for its ideal of friendship, in the Fifth Century BCE, who fell out with Dionysius I, the tyrannical king of Sicily. One of the youths, Pythias, was cast into prison and condemned to die. He asked that he be allowed to visit his family and say his farewells. Fearing he would disappear forever, the king refused. His companion, Damon, offered to take his place in prison and, should Pythias not return at the appointed time, would die in his place. The offer was accepted and the exchange took place. As the day for execution approached the condemned youth did not appear. At the last moment, Pythias returns having been delayed by a pirate attack in which he was thrown overboard and had to swim to shore and make his way back as quickly as possible. Dionysius is so impressed with this loyalty that he frees them both. Charles Dickens wrote, in "A Tale of Two Cities" of nobility of Sydney Carton, who voluntarily goes to the guillotine in place of Charles Darnay because he is a better man than he, even though Darnay's death would open Carton's way to the woman he loves.. There are a multitude of similar stories that have come out of the many wars that have been fought.

The Holy Scriptures are not without examples of this "philia" (brotherly love). Jonathan remained David's best friend even though he knew David would become king in his place, aiding him and preserving him in defiance of his father, King Saul. The ultimate example is Jesus Christ who left His throne of glory in Heaven, for the sole purpose of bringing the Gospel to earth and redeeming mankind as the only possible sacrifice for all the sins which He had never committed. The emphasis of His teaching was the love of God for man and the need for man to love man. It all is summed up in John 3:16-17, "For God so loved the world that he gave his only Son, so that everyone who believes in him may not perish but may have eternal life. 'Indeed, God did not send the Son into the world to condemn the world, but in order that the world might be saved through him", and His words in John 15:13-14, "Greater love hath no man than this, that a man lay down his life for his friends. Ye are my friends, if you do whatsoever I command you...."



A History of MWDs

A K9 in military service, or a Military Working Dog (MWD) has been defined as "a canine that has been trained to protect humans in dangerous situations."

Dogs, unlike humans, cannot be bribed, corrupted or bought. MWDs are true to their masters and their service, until they take their last breaths.

"With the creation of the United States K9 Corps on March 13, 1942, dogs were officially adopted in the U.S. military ranks during WWII."

Dogs in military service date back to the seventh century B.C., but it wasn't until World War II that dogs were widely used, mostly as message carriers. These dogs were in such high demand that American families were donating their dogs into service. The Army's Dogs for Defense program trained 10,000 of the donated dogs. It's been reported that approximately 1,000 dogs were killed in action.

Once trained these MWDs were deployed in action. Not only used by the Army, the Navy used these dogs to guard our shipyards, the USCG used the K9s to patrol our shorelines here at home, and the Marine Corps used these dogs to help recapture islands in the Pacific.

It's always been a dangerous job. During the Vietnam War, around 5,000 K9s were pressed into service along with 10,000 dog handlers. The dogs did such a good job that a bounty of up to \$20.000 were placed on their heads. "It was also reported that 232 MWDs and 295 dog handlers were killed in action."

Unfortunately, these specially trained dogs were treated as "equipment", and were either left behind on foreign soil or euthanized after their usefulness after the wars played out. That is no longer the case! Thanks to

Representative Roscoe Bartlet, who introduced a bill (Robby's Law) on September 27, 2000, that changed the fate of MWDs. Robby was a MWD who was refused adoption by his handler and subsequently euthanized. "President Bill Clinton signed the bill into law in November of 2000." Robby's Law required allowing all MWDs to be adopted after their service was complete.

On June 1, 2015, the Military Dog Retirement Bill, a bill sponsored by Representative Walter Jones, Senator Richard Blumenthal, and the U. S. War Dog Association was introduced that ensured the MWD could no longer be deemed "equipment." It was passed by both the Senate and House and was signed into law by President Barack Obama. Not only that, but the law stipulates that the Department of Defense must arrange for and then pay for transportation of the trained military dogs back to the United States upon their retirement from service when they are working overseas.

Approximately 3,000 MWDs are at work and serve in a variety of capacities and operate with multiple agencies, including the military, border patrol, U.S. Customs, federal law enforcement, and police K9 units.

We all saw them in Vietnam and maybe in some other places. Now we know a little bit more about them.
