## Traffic Action Plan (TAP)

Bethany Lopez (along with Brad Underwood) presented plans for the restriping of Bermuda between Ginnever and Trinity at the last Board meeting. This would allow a left turn into Fiesta Gardens School to try to address school traffic issues. The trade-off is the lanes would be narrower. Feedback from those who attended the meeting was important and changes to the plans will be made. When the new plans are drawn up we will make them available for residents to view.

### Bulb-outs

Construction of the bulb-outs is completed. Re-striping of the Ginnever/Bermuda intersection will happen soon which includes more obvious crossings and replacement of the bike-lane striping between Bermuda and 19<sup>th</sup> with the shared bike lane striping. After initial anxiety over the bulb-outs, the general response to them has been favorable. Please continue to give the Board members feedback on positives and negatives so we can keep the city informed.

### **Residential Parking Program**

We continue to have discussions with the Public Works Department regarding a parking program in Fiesta Gardens. The current RPPP is designed more for decreasing parking from businesses/retail/schools. However, all requests are going to be

put on hold as the city is going to reassess the residential parking permit program to better address the needs of San Mateo residents. Please let us know what frustrates you about parking in Fiesta Gardens, and the causes, so we can pass this on to the city to be considered as they revamp the program.

## **City Planning**

More housing is being planned near our congested neighborhood.

- A development of 190 units with 418 parking spaces was proposed at the San Mateo planning meeting by Strada Investment Group. This would replace office space at the Waters Office Park on South Norfolk Street (just south of Bayside Building Materials).
- An additional 68-unit affordable housing project (BRIDGE housing) was proposed for the Bay Meadows development near the Nueva School. 2775 S Delaware St. (PA17-060).

74 residences with 13,462 square feet of ground floor retail is approved for Hillsdale terraces on El Camino between 27<sup>th</sup> and 28<sup>th</sup>. (PA15-031).

## General

I was disappointed to see a low turnout at this month's Board meeting to see the Public Works Department presentation. As Board members we hear a lot of complaints, but then do not see those who complain turn up to meetings arranged to provide important information that will affect the neighborhood. If you don't attend meetings, don't read the Bee, please do not get frustrated when you see the city making changes with which you disagree. Getting involved earlier means your opinion may actually count.
