1. The undersigned understands and acknowledges that this type of competition can be dangerous or hazardous by its very nature. The undersigned also acknowledges that the activity of handling firearms and other lethal implements is an inherently dangerous activity and hereby expressly agrees to accept and assume all such dangers and risks.

2. The undersigned will indemnify, defend, and hold proprietor and its agents, employees, invitees, or visitors harmless against all claims, damages, costs and/or injuries incurred by student or alleged against proprietor arising out of acts or omissions of the undersigned or any of the undersigned's agents, employees, contractors, visitors, other students, or licensees while at the premises, including any claims based on any injury to or death of any persons or damage to or loss of property.

3. The undersigned waives all claims against proprietor and releases proprietor from any liability, based on any injury to or death of participant or damage to or loss of any property belonging to participant.

4. THE FOREGOING INDEMNITIES, WAIVERS, AND RELEASES WILL APPLY EVEN IF THE INCIDENT GIVING RISE TO THE CLAIMS IS CAUSED IN WHOLE OR IN PART BY THE CONDITION OF THE PREMISES OR BY THE SOLE OR CONCURRENT ORDINARY NEGLIGENCE OF PROPRIETOR.

5. The undersigned acknowledges that as a substantial and material term of the contract entered into with proprietor and his willingness to hold the event and allow participant's participation in said event is conditioned on my willingness to sign, agree and be bound by all the terms of this release, indemnity, and assumption of risks document.

6. The undersigned also acknowledges this Release, Waiver and Hold Harmless Agreement is intended to apply to, but not be limited to, all medical, hospital, or other expenses associated with or incurred in connection with any of the described activity on Mr. Ken Stormer's property. Additionally, any claims for lost wages, pain and suffering or any other claim for monetary damages arising from any injury relating to the activities on Mr. Ken Stormer's property are hereby waived.

7. By my signature below I hereby acknowledge I have received and reviewed the Range Rules, Standard Operating Procedures and Safety Protocols of Red River West, LLC. I acknowledge I have agreed to abide by the Range Rules provided. Nothing in either document is intended to be in conflict or contradict the other. Should any provision of the Range Rules contradict or be inconsistent with the Release, Waver, Indemnification, Hold Harmless and Assumption of Risks Agreement, the Release document shall control and supersede any inconsistency with the Range Rule document.

8. It has been explained and I understand the nature of this particular outdoor range. Specifically, this facility is located in a remote rural setting far from any medical facilities. I understand and assume the risks associated with the remote and isolated nature of this facility in order to take advantage of the opportunities afforded by such location. These opportunities include, but are not limited to, long range shooting, night time and low light shooting, shooting on the move, and other opportunities simply not possible with an indoor range or more conventional outdoor shooting facility. In addition to the distance and time restrictions for medical treatment, it has been explained and I understand the rural and remote nature of the facility necessarily

includes other dangers not typically present with other facilities. These other dangers include, but are not limited to, poisonous snakes, wild and potentially dangerous animals (i.e. wild hogs, coyotes, mountain lions and others), and rough and rugged terrain upon which it is possible to sustain various physical injuries. I hereby acknowledge all of the inherent dangers this type of facility presents and voluntarily accept responsibility for all of these potential dangers in exchange for the opportunity to use this facility.

9. I expressly represent, warrant and acknowledge that I am an experienced shooter familiar with the following rules of firearms safety:

**INITIALS:**

- \_\_\_\_\_ 1. Treat all guns as if they are always loaded;
- \_\_\_\_\_ 2. Never point a firearm at anything you are not willing to destroy, including yourself, and never allow the muzzle to cover anything you are not willing to destroy.
- \_\_\_\_\_ 3. Keep your finger off the trigger at all times until the sites are on target and you are ready to fire;
- \_\_\_\_\_ 4. Be aware of all targets, foreground, background, left and right;
- \_\_\_\_\_ 5. In addition to these cardinal rules I represent that I am familiar with the mechanical operation of my firearm and it is a functional and safe piece of equipment with which to participate in this class; and
- \_\_\_\_\_ 6. Finally, I am familiar with all safety protocols of loading, unloading, transporting and storing all weapon systems I have brought to use and participate with in this event.

**RED RIVER WEST, LLC RANGE RULES,  
STANDARD OPERATING PROCEDURES AND SAFETY PROTOCOLS**

1. All guns are always loaded. If you checked it, check it again then treat the gun as if it were loaded... ALWAYS.
2. Never point a gun at anything you are not willing to destroy, NEVER! This includes yourself!
3. Keep your finger off the trigger until your sights are on the target and you are ready to fire.
4. Know your targets foreground, background, left and right. Be aware of your firearm and target.
5. Safety glasses and hearing protection is required to be worn at all times. (Electronic ear pro preferred.)
6. NO loading or unloading firearms off the firing line. Carbines and shotguns must be in the rack provided if you leave the staging area (tables/re-loading area.)
7. No firearms manipulations off the firing line (i.e., staging area, parking lot, tent, picnic table area, etc.)
8. No show and tell, loading or unloading in the parking area. **CHL HOLDERS:** If you need to unload a firearm(s) locate a Staff Range Officer and they will take you to the designated area.
9. **AMERICAN MADE BRASS CASE, COPPER JACKETED AMMO ONLY. NO STEEL CASE, ALUMINUM CASE, ARMOR PIERCING, (M855, green tip, SS109, tungsten penetrator, black tip, etc.), XM-193, TRACER, INCENDIARY, STEEL CORE OR COMMUNIST BLOCK AMMUNITION IS ALLOWED. (HAND LOADS WILL BE ALLOWED FOR THIS EVENT.)**
10. **It is now the policy of Red River West to inspect all ammo brought for use at our facility. This is to ensure that all ammo is safe for use here and complies with our Ammo Restrictions policy. If ammo is found that does not comply, you will forfeit your time at the range and will be asked to leave. Again, this is for the safety of all persons at the range as well as for the protection of our property and targetry.**
11. All participants will ensure all of their weapons are cleared with the magazine out and bolt open at all times. Gas guns, magazines out and bolt must be locked to the rear.
12. Chamber flags or other Empty Chamber Indicator (ECI) will be utilized at all times.
13. Shoot only at designated targets and only with designated number of rounds when the firing line is "hot".
14. Stay with the stage COF (NO 'HOTRODDING'.)
15. If you do something 'dangerous' you may be removed from the property; no arguments, no refunds; you did it to yourself.
16. If you are cautioned, do not take it personally; it's done for safety reasons only.
17. DO NOT argue with the Range Officers. (MY RANGE, MY RULES.)
18. Use common courtesy, stay together as a squad. (Don't be 'that guy'.)
19. If anyone has any physical or medical issues or concerns, please tell Match Directors or one of the RO's before the start of class.
20. No use of alcohol, illegal drugs or use of judgment impairing medications is allowed. Any questions, please ask.
21. No photography and/or video is allowed without the prior written consent of Red River West, LLC and anything used must be approved by Red River West, LLC prior to release.
22. Any questions on any of this, please ask.

Thanks in advance for following these Range Rules and Safety Protocols; they were developed for your safety over the last 30 years here at Red River West. Our safety rules are very stringent because we are committed to safety.
