- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and
- WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and
- WHEREAS, the Summit Lake Paiute Tribe is committed to the conservation of cultural and natural resources within the Summit Lake Indian Reservation ("Reservation") and to the long-term protection, preservation, and management of these resources; and
- WHEREAS, the Summit Lake Paiute Tribe currently administers Bureau of Indian Affairs (BIA) grants for the Fisheries (A22AV00034/Fund 164), Roads (A22AV00031/Fund 162), and Range (A22AV00032/Fund 163) Management Programs at the Reservation; and
- WHEREAS, the Natural Resources Department will submit to BIA the FY24 Statements of Work and Budgets for the Fisheries, Roads, and Range Management Programs with no changes from the original application; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to submitting the above documents to BIA.

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
