For ordinance levying taxes for the Village of Sheridan for the fiscal year commencing April 1, 2024 and ending March 31, 2025, BE IT ORDAINED by the President and Board of Trustees as follows:

**SECTION 1: GENERAL CORPORATE PURPOSE LEVY**

(a) That of the total amount of \$152,472.00 of appropriated expenditures for general administrative purposes for the 2024/2025 fiscal year for the Village of Sheridan, there requires to be raised by taxation as provided by 65 ILCS 5/8-3-1 the sum of \$16,259.00.

(b) That accordingly, for general administrative purposes, the sum of \$16,259.00 shall be and the same hereby is levied on all property subject to taxation within the corporate limits of the Village of Sheridan as said property is assessed and equalized for state and county purposes for said year.

(b) That accordingly, for liability and insurance fund purposes, the sum of \$30,614.00 shall be and the same hereby is levied on all property subject to taxation within the corporate limits of the Village of Sheridan as said property is assessed and equalized for state and county purposes for said year.

(c) That the object and purposes of said levy are for the amounts appropriated as follows:

(b) That accordingly, for general administrative purposes, the sum of \$3,200.00 shall be and the same hereby is levied on all property subject to taxation within the corporate limits of the Village of Sheridan as said property is assessed and equalized for state and county purposes for said year.

(c) That the object and purposes of said levy are for the amounts appropriated as follows:

The foregoing Ordinance was duly passed by the President and Board Trustees of the Village of Sheridan this 9th day of December, 2024.

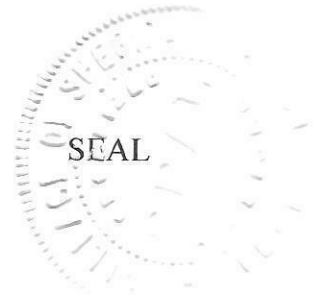

OF THE PROPERTY TAX CODE

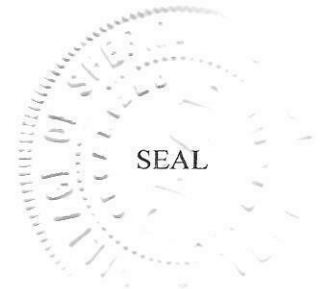
