REGIONAL PHOTO SHOW 2021 PROSPECTUS

Photo Show

All types of photography are accepted in this show including, but not limited to:

- Traditional Photography: Black and white, color, or toned, shot digitally or with film. The image has conventional post-processing techniques that enhance the image's appearance without changing the original content. Cropping, sharpening, dodging, burning, moderate enhancements to color and contrast, and removal of obtrusive artifacts such as dust specks are allowed.
- Digitally Enhanced: An image which begins with a photograph and has been digitally edited or enhanced on a computer or by other means beyond normal darkroom technique so that the image's appearance is significantly changed from the appearance of the original photograph. Images in this category include montages, may have subjects or lighting added or removed, or make heavy use of digital filters or plugins, strongly enhanced colors, photos stitched into a panorama or HDR.
- Vintage and Alternative Processes: Photographic processes such as the cyanotype, photogram, daguerreotype, tintype and others. This is the perfect opportunity to show off your darkroom skill and creative vision.

**Works created entirely by digital means are not accepted in this show.*

Important Dates

- Delivery of Art: Thursday, June 24 through Saturday, June 26 during gallery hours*
- Show Dates: Thursday, July 1 to Saturday, July 31
- Reception: Saturday, July 17 from 4:00 pm to 6:00 pm
- Removal of Art: Sunday, August 1 from 11 am to 3:00 pm, and during following gallery hours

**Special accommodations may be possible by contacting Wayne Arts at least 5 days ahead by email*

Eligibility

- This is a judged show that is open to all photographers, both members and non-members.
- The photograph must be the original work of the submitting artist.
- A photographic process must have been used in the production of the work. (Scanned work is acceptable, digital art that did not originate from a photographic process is not).
- Works that have previously been exhibited at Wayne Arts are not eligible.

Entry

- Up to 3 pieces; \$30/Member and \$45/Non-member
- Cash, credit card, or check made payable to Wayne County Council for the Arts are accepted.
- All fees are non-refundable.

Presentation Specifications

- All work must be wired for hanging so the wire does not show when hung.
- Photographic prints, except those on canvas or metal, must be framed behind glass or plexiglass
- Works on canvas must be neatly wrapped.
- Minimum size of the actual image is 8" x 10". Large works must not exceed 72 United Inches including frame (United Inches = length + width. For example a 16" x 20" framed piece is 36 United Inches.)
- Frames and mats used need to be clean and in good repair.
- Framed works larger than 18 x 24" must be framed using plexiglass/acrylic, not regular glass due to weight.
- Prints on metal are also acceptable as long as they have a hanging device on the back.

**Wayne Arts reserves the right to reject any art that does not meet the presentation specifications.*

Sale of Exhibited Artwork

Works not for sale must be marked NFS on the entry form. All sales are handled through the Artist. In the event there is interest in purchasing art, the artist is put in direct contact with the interested party and receives 100% of proceeds from any resulting sales. Wayne Arts will mark the piece as sold and will ask buyer to complete information so the artist may contact them for payment and time and place to pick up art. Artists will have full responsibility for paying all applicable sales tax.

All work including work sold during the show must remain in the gallery until the end of the show.

Awards

Cash prizes will be awarded. Only one award may be given to an individual. The decision of the juror is final.

Liability

While all reasonable care will be taken in handling work, Wayne County Council for the Arts does not carry insurance for submitted works and will not assume responsibility for any damage to the artwork during delivery, installation, exhibit, and de-installation including, but not limited to, normal wear and tear, such as minor nicks to frames or scratches to Plexiglas. It is suggested that an artist wanting more protection should insure his or her own art (some homeowner's policies may include protection and should be checked).
