## Just a thought...

*Maryland's Sex Offender Registry - What is it?*



It has been ten years since Maryland started registering convicted sex offenders. During that time, over 5,000 individuals have submitted registration statements to state officials, and on any given day, the names and photographs of more than 4,300 of those offenders appear on the Internet as active registrations. Registered offenders live in every county and city across the state. A task that once started out as a part-time effort has grown into full-time work for dozens of criminal justice professionals throughout Maryland.

### What is Sex Offender Registration?

As a result of federal legislation passed in 1996, commonly referred to as Megan's Law, citizens now have the right to know where convicted sex offenders live. The most common way for individuals to learn about regis-

tered sex offenders is through Internet websites hosted by government agencies. A number of private organizations and companies have also developed their own websites, repackaging the information available from free sites and marketing the data with special search routines and mapping capabilities. Many of these non-governmental websites charge a fee for the information that is usually available for free from a government operated site. In Maryland, printed copies of the registries can also be obtained and many local law enforcement agencies have policies that allow for other means of community notification.



### Maryland's Sex Offender Registry

The state of Maryland maintains an extensive website devoted to managing sexual offender

registration. By visiting [www.socem.info](http://www.socem.info) individuals can search for known offenders by name or zip code, learn about Maryland registration law, identify the local law enforcement agencies responsible for registration within each county, and learn how to register for a free notification service. The notification service, called the Maryland Sex Offender Alert Line, provides timely notification in conjunction with a personal safety plan individuals can implement to greatly reduce their risk of sexual assault.

The key to effective use of sexual offender registration data is to keep a balanced view of the information. Do not panic or overreact when you learn that a registered sex offender lives in your area. Remember that sex offenders have always lived in our communities, but now you have the right to know who they are and where they live. You should also keep in mind that the absence of any registered sex offenders in your area should not create a false sense of security. Sex offender registry information should be used with the knowledge that most sex offenders victimized someone that they knew prior to the offense and that many have not been convicted and do not appear on any registry.

When developing a personal safety plan, you should assume that it is your own responsibility to prevent sexual assault and not someone else's. Start by knowing the issues and

News From the Field

*Everyone knows that the field of victims services is always evolving. The challenge is to find a way to keep on top of all the changes ... we're here to help! Here's an overview of just some of the most recent legislative changes:*

SB 115 - Passed unanimously in the Senate, and is now pending a House decision. This bill alters a specified time limit for filing a claim with the Criminal Injuries Compensation Board.

SB 306/ HB 1258 - Defeated in the Senate (24 v. 25). This bill would have required the Motor Vehicle Administration [MVA] to develop and make available a specially designed registration plate promoting awareness and support for victims of crimes and requiring MVA to consult with the Maryland Crime Victims' Resource Center.

Senate Committee Hearings have been held, however no further action has been taken on the following bills:



SB162/ HB632 and SB232/ HB323 - Court Electronic Records and Public Records. Preventing the remote access to identifying information

of a victim or witness in a criminal case and preventing electronic (Internet) copying of identifying information of a victim or witness in a criminal case that is not available by remote access at public computer terminals.

SB222/ HB320 - Victim Witness Intimidation. Expanding the categories of crimes for which a specified type of evidence is admissible at trial under specified circumstances, and expanding the list of crimes applicable to specified provisions that provide a greater penalty if committed against specified persons.

understanding the statistics. Increase your knowledge about risk reduction measures that you can take to protect yourself and your family. By understanding sexual assault and abuse, you can avoid potentially dangerous situations and take preventative actions before an incident of victimization occurs. Finally, be aware of the media's ability to sensationalize shocking or horrendous events. While stories of abduction and serious injury or death inflicted by strangers are real and terrifying, they are not the norm. By using the sex offender registry as part of your safety plan you can reduce the risk of sexual assault.

## Hot Topics

In the past year, Governor Ehrlich has charged his office with the initiative to improve and upgrade the Maryland Sex Offender Registry. National attention to the problems of sex offenders heightened awareness of the need for Maryland to assess their current situation and to use the results of those assessment questions to focus on achieving four of Governor Ehrlich's goals: 1.) Better protection of communities; 2.) Better service to victims; 3.) Better monitoring of offenders; and 4.) Better technology.

As a result of the Governor's initiatives, this past year has yielded considerable successes:

1. Sex Offender Registry Improvement/ Upgrade - a) \$300,000 for web-based registration; b) computer and digital cameras distributed statewide; c) email directly from the Sex Offender Registry to provide tips on the location of non-compliant offenders; d) offender mapping; e) SOCEM registry contains only wanted and non-compliant offenders

([www.socem.info](http://www.socem.info)); f) low-tech email to law enforcement; and g) community notification through automated systems.

2. Enhanced Amber Alert - Governor Ehrlich was the first Governor in the U.S. to require that all State cell phones be able to receive Amber Alerts. Any cell phone user can register to receive free and immediate Amber Alert text message by registering at [www.wirelessamberalerts.org](http://www.wirelessamberalerts.org)

3. Stepped Up Community Protection - a) Governor Ehrlich's budget included \$850,000 for sex offender registration and enforcement through partnerships with local police chiefs and sheriffs; b) MVA ID cards for sex offenders re-entering the community from state correctional facilities; c) 100% audit of existing caseloads by the Division of Parole and Probation to ensure correct classification and location of sex offenders; d) Maryland law enforcement officers are now alerted during traffic stops that the vehicle's owner is a sex offender and if that person is compliant; and e) Maryland State Police coordination in apprehension of wanted persons, Internet investigations and sexual predators.

4. Commitment to Victim and Family Assistance - a) \$2 million distributed through the network of Child Advocacy Centers for services to child victims of sexual abuse and their families; b) additional counselors funded; and c) training and intervention

The tremendous work done by the Governor's Office of Crime Control and Prevention has had many focused criminal justice personnel involved to account for the successes thus far. Mr. Herman Ingram, Chief of the Victim's Division, and Mr. John Tewey, Chief of the C-SAFE Division, recently presented the information contained herein at this year's Academy. We had the pleasure of speaking with Mr. Ingram after the presentation to get a more personal view on his opinion of the impact the Governor's initiatives will have on the future of safeguarding children in Maryland from these sexual offenders.

### Hot Topics (Cont.)

**Academy Forum:** Mr. Ingram, of all the components of Governor Ehrlich's initiatives, is there one aspect that you believe is the most significant to the safety of our children from sex offenders, and why?

**Mr. Ingram:** Governor Ehrlich said it best - he wanted immediate help for child victims of sex crimes and their families. He accomplished that with \$2 million of new money for services and staff. He wanted the sex offender registry to notify citizens when a sex offender moves into the community, and this is now in place through VINE (Victim Information and Notification Everyday)

**AF:** Can you explain what GOCCP will be doing in the next year to further the Governor's initiatives? Is there a specific area of the plan that will be concentrated on the most?

**Mr. Ingram:** Governor Ehrlich wants GOCCP to continue its support of community public safety and service initiatives, such as the Child Advocacy Centers, C-SAFE, SOCEM, as well as addressing sex offenders, gangs, and the emerging problem of methamphetamine labs.

**AF:** Can you summarize your feelings about the whole Governor's Sex Offender Registry initiative and its impact on child safety for us?

**Mr. Ingram:** The Governor recently visited Glen Burnie to congratulate the principal and staff of the Glendale Elementary School. A sex offender attempted to remove a child from the school. The school staff, using the sex offender registry, recognized the individual and called the police, and the man was arrested. This is an example of the State and local effort we need to keep our children safe from sexual predators.
