IV. PROGRAM – Don Kremer, new Animal Shelter CEO

Only open acceptance shelter in Wyoming. Five animal enforcement officers. They have a 100% conviction rate. If there is an animal on sight, they AEOs are the first in the building. They have staff veterinarians. No dog rabies cases in the (plenty of skunks). Don shared a number of slides showing animals that have come through the shelter: bull snake, snapping turtle, rattle snakes, 4' alligator (given to a reptile farm in S. Dakota), bunnies (released in the park by Botanic Gardens), racoons, cougar, badgers, pets trapped in window wells (skunks, too); 63 dogs in a trailer in Walmart parking lot; Dogs outside in cage in sub-zero temperature; When hoarding cases come to the shelter, there is expense in keeping the animals - \$39,000 in one case – no reimbursement from city or county. Very dependent on donations to offset these types of costs. Pictures and stories were shared of bite cases and hoarding cases.

Staff psychologist – mental health of shelter workers.

Very labor intensive – Every day the animals are fed and watered, kennels cleaned and sanitized, new bedding, dogs walked and socialized.

Spay and neuter operations, medical treatment, lost animals returned, treated and vaccinated, monitored for sickness, sanitization in maintained.

Funded by city and county, \$700,000 per year.

\$2,000,000 + projected budget. Any and all volunteers and donations are welcome.
