1. Roll call: Selectman Dan Chamberlain, Selectman Melissa Patterson, & Selectman Robin Cyr present.
2. Secretary's Report: Mrs. Patterson motioned to accept the secretary's report as written. Ms. Cyr seconded, all voted in favor.
3. Nominations for 2017 Benton Spirit of America Recipient(s): Mrs. Patterson motioned to nominate Leo & June Caron for the 2017 Benton Spirit of America Award. Ms. Cyr seconded, all voted in favor.

5. Road Commissioner's Report: Mr. Chamberlain spoke with Todd Littlefield. Mr. Littlefield informed Mr. Chamberlain that the Benton roads look great. Mr. Chamberlain feels the roads are the best he has seen them in years and is very impressed with Nitram. The office has only received 1 mailbox complaint. This is outstanding compared to prior years.

  - Alan Fuller Broad Band*: Mr. Fuller gave an update of the possibility of Broad Band coming to Benton. He will be giving further updates in the future.
  - Resident/Non-Resident Availability to Sand Shed*: Mr. Chamberlain spoke of the Benton sand shed and the theft of sand. Mr. Chamberlain was shocked to learn the extent of abuse. Clinton town manager Pam called Mrs. Patterson to inform her of Clinton residents coming to the Benton sand shed for their supply. The Town of Benton has installed 2 signs at the sand shed and is looking at the possibility of cameras.
