Village of Pablo Residents,

REVISED – AMENITY CENTER OPENING WEDNESDAY, MAY 20, 2019. For the safety of our residents, a decision has been reached by the Homeowners Association Board to keep the Amenity Center CLOSED until such a time that Governor DeSantis moves the state into Phase Two of his "Safe. Smart. Step-by-Step Plan" for Florida's Recovery. Ahead of any reopening activities we would like to use this opportunity to communicate some additional safety guidance for the use of the Amenity Center/Pool.

Using a reasonable care standard based off the Center for Disease Control Guidelines, the following COVID-19 guidelines should be observed in addition to the Villages of Pablo Amenity Center Area – Rules and Regulations:

The Amenity Center will be open from 11:00 – 7:00 p.m. Only. A full-time monitor will be in place at the Amenity Center during these hours. It is the responsibility of each visitor to remain vigilant in practicing social distancing guidelines. Some suggestions (not all inclusive):

- Remain 6ft apart from anyone not in your household this applies to pool bathers as well
- Observe overall capacity limits for the pools:
 - o Lap pool = 30 total swimmers at one time / Kidney Pool = 26 total swimmers at one time
- Limit group activities

Even though bathrooms, chairs, tables, etc. will be cleaned /sanitized every day, it remains very important that visitors wash their hands often with soap and water for at least 20 seconds. This is especially important when:

- Visiting the bathroom
- Eating/drinking
- Blowing/wiping your nose, coughing or sneezing into a tissue or a bent arm
- Touching someone
- Concluding recreational activities

Note: If you don't have soap and water, use a 60% or more alcohol-based hand sanitizer

- Throw used tissues, wipes, and unfinished food/drink items in the trash
- If you are feeling sick or have been sick, please do not enter the Amenity Center
- Those with underlying health issues should carefully (and personally) decide whether or not they can safely enter the Amenity Center under these rules

Member's dependents under 16 years of age must be accompanied to the Amenity Center by a responsible homeowner, homeowners adult dependent (18 or older), bona fide adult renter of a homeowner or renter's dependent, age 18 or older. The adult must remain with the minor throughout their visit to the center

Each household will be allowed to bring 2 guests and must remain with their guests throughout their visit to the center.

These rules will remain in place until the Covid-19 virus has run its course and we have been given the 'all clear' from government officials.

We apologize for the inconvenience the delay in opening may cause. By using this time as an opportunity to create and communicate guidelines to help keep our residents healthy, we will be ready for a fun, safe reopening.
