Minutes

A motion was made by Marcia, seconded by Candy to approve the minutes of October 2017. The motion was unanimously approved.

Treasurer's Report

Jenny gave the Treasurer's Report which shows a balance of \$6311.24. Expenditures were \$5.02 for Facebook boost. (Sullivan Exhibit)

Communications

Robert would like to get art pieces that were brought down. These are pieces that are separate from the collection. A motion was made by Wanda, seconded by Candy to allow Robert to take the pieces he has asked for because they are not part of the collection. The motion was unanimously approved. Some ideas would be an exhibit of children's art work within the gallery. Another would be a family night at the museum. She is working on other ideas & will report later.

Old Business

Orbs – Jenny reported that the city does not want to have the orbs at the Donna Harris park this year. Joyce will ask Parkview Nursing Home if they would like the orbs for their Christmas display. Frank Martin will be bringing all the orbs stored at the city to the store room at the library. Wanda & Candy will work on the orbs (Checking the lights).

December Exhibit – It was decided that for the exhibit we will all bring creches` to be displayed. We will also bring religious art to be displayed on the wall. It was discussed to also fill in the wreaths and other greenery as needed. We will meet Saturday, December 2nd at 9:00.

Returned Art Work – We have two boxes that have been returned from the Juried Art show. Jenelle & Sonja have tried to contact the artists with no answers. The time has elapsed and the pieces are now the property of the Walker Art collection. They are a cast aluminum sculpture entitled "Wrestle" by Ameilia Volwiler-Stanley, with a value of \$700 and a mixed media piece entitled "Gillian's Gate" by Sara Slee-Brown with a value of \$200.

New Business

Board Vacancies – John Wilson will have to resign from the board as he has other obligations on meeting day. He would like to stay on as an ambassador. There are three vacancies that need to be filled. One vacancy will need to be appointed by the city. The other two will need to be appointed by the committee. A motion was made by Jenny, seconded by Wanda to appoint Joyce Martin as board member. The motion was unanimously approved. Candy will ask Tammy Heistand to see if she would be interested. Joyce reported that she has asked the art teacher at ACJSH, but not sure that he is interested. Jenny will ask Kristie Kinney if we have had any applicants from the city. Jenny will also put on our Facebook page about the vacancies.

We will not have a business meeting next month but will meet December 21st at 4:00 at Candy Hewes home.

There being no further business to discuss Wanda adjourned the meeting at 4:55.
