Primary Responsibilities

The Air Quality & Noise Analyst prepares technically sound and legally defensible air quality and noise impact assessments for projects primarily subject to the California Environmental Quality Act (CEQA) and/or the National Environmental Policy Act (NEPA).

Specific Responsibilities

- Prepare technical documentation and analyses related to the evaluation of air quality, greenhouse gas, health risk, noise, and groundborne vibration impacts.
- Prepare environmental documentation in support of projects subject to CEQA and/or NEPA.
- Develop and implement air quality and noise mitigation monitoring plans and investigations.
- Develop, evaluate and interpret policy documents such as General Plan air quality and noise elements.
- Effectively manage projects, including the management of projects within specified budgets and the preparation of scopes of work, costs, and schedules.
- Provide support and assistance, as requested, in office administration functions including, but not limited to, the maintenance of project files, computer systems, software programs, and equipment.
- Attend and represent the employer at meetings, professional conferences and training events.
- Develop and maintain mutually beneficial relationships with clients and colleagues.
- Perform fieldwork throughout California and neighboring states for the collection of data and evaluation of site conditions.
- Prepare marketing and proposal documentation.

- Ability to plan, organize and coordinate impact assessments.
- Ability to provide effective and quality communication through written and oral methods.
- Work creatively as a member of an environmental assessment team.
- Promote teamwork through interpersonal skills.
