RULES & GUIDELINES - FOR 2016 SCHOLARSHIP

- 1. **NO** 2015-2016 high school graduates will be considered for the 2016 scholarship. Applicant MUST have had a break from High School of one year or more.
- 2. Applicant must be a member in good standing with APWU National Auxiliary. The applicant must have been an Auxiliary member in good standing, for at least one (1) year prior to application deadline.
- 3. Application must be on official application form from the APWU National Auxiliary Continuing Education Scholarship Program.
- 4. Applicant must write an essay on the designated subject of no less than 175 and no greater than 250 words.
- 5. Applicant recipient must attend an accredited school (college, university, vocational or technical school, etc.).
- 6. Completed application form with essay must be mailed to: Chairperson Debra Stewart (the address on back) post-marked no later than July 1, 2016, by certified mail with return receipt requested.
- 7. Applicant must be registered, enrolled or attending an accredited college (college, university, vocational or technical school, etc.) at the time the scholarship is given.
- 8. The APWU National Auxiliary will award one (1) yearly scholarship of \$750.00.
- 9. Upon verification that the recipient has enrolled with the school of his/her choice, the award will be sent to the business office of the school to be applied to the cost of tuition. Scholarship must be used within 18 months of award date
- 10. The scholarship recipient is eligible to receive one (1) yearly scholarship for a maximum of two (2) years upon reapplication & selection process in accordance with the rules and guidelines of the scholarship.
- 11. No member of the APWU Auxiliary National Executive Board or their family will be eligible for this scholarship.
- 12. NO EXCEPTIONS WILL BE MADE TO THESE RULES.

TO ALL LOCAL AND STATE AUXILIARIES AND MEMBERS-AT-LARGE LOCALS WITHOUT LEADERS

AUXILIARY CONVENTION CALL

Official notice is hereby given that the National Convention of the Auxiliary to the American Postal Workers Union will convene in Orlando, Florida August 22-25, 2016 and will continue in daily session until the business of the convention is completed. Official convention headquarters for the Auxiliary will be at the Swan Hotel.

The Legislative objectives of the American Postal Workers Union, extending knowledge of the political operations of the government and support of the Human Relations programs of the APWU are the primary purposes and the programs of the Auxiliary. Our parent organization needs and expects our support and activities in the legislative, political and Human Relations fields as well as in other areas. Future Auxiliary support and activities will be formulated at this convention, plus review of the constitution and by-laws of the Auxiliary to the American Postal Workers Union.

Therefore: State and Local Auxiliaries are urged to send their full quota of delegates. Delegates should be elected early. The delegates should be well informed on the purpose, activities of the Auxiliary, and actions desired by their State and Local Auxiliaries. Members-at-Large and members of Locals Without Leaders (LWOL) are also urged to attend and avail themselves of progress of our Auxiliary. Visitors are encouraged to register as guests and attend all meetings and functions of the convention.

Excerpts from the Constitution and by-laws ARTICLE V – REPRESENTATION

- Sec. 1 a) Per capita tax representation shall be based on the amount of per capita tax received twenty (20) days prior to the opening of the National Auxiliary Convention.
 - b) In order to be seated as a delegate and able to vote on any issue during the National Convention, the per capita tax must be received by the National Treasurer at least twenty (20) days prior to the opening of the National Auxiliary Convention.
 - c) The minimum age to be seated as a delegate on the National Convention floor shall be twelve (12).
- Sec. 2 a) Every Area Local and Local Auxiliary shall be entitled to a minimum of five (5) votes plus one (1) additional vote for each ten (10) members or major fraction thereof
 - b) LWOL chapters shall be entitled to four (4) votes. National Convention credentials for LWOL delegates must be verified by the Credential Committee and signed by the credential chairperson, and/or the National Auxiliary President and the National Secretary.
 - c) Each member-at-large attending the convention shall have one (1) vote.
 - d) Each National Officer shall be entitled to one (1) vote.
 - e) Any past National President of the Auxiliary to the American Postal Workers Union shall be seated as a delegate on the convention floor with one (1) vote.
- Sec. 3 One or more delegates may cast the full number of votes to which their Auxiliary is entitled provided no vote is divided smaller that one (1) vote per delegate. No proxy votes shall be allowed.
- Sec. 4 a) Credentials of delegates shall be sent so as to reach the National Secretary not later than thirty (30) days before the convening of the National Convention. These credentials shall be tabulated by states in alphabetical order and shall be furnished to the National President not later than fifteen (15) days preceding the National Convention. State Delegates credentials shall be accepted later, in the event State Conventions are held less than thirty (30) days prior to the National Convention. The credentials chairperson at the National Convention shall not accept any credentials, which have not been properly authorized by the officers of the respective Auxiliaries.
 - b) Alternate delegates may be seated in the permanent absence of regular delegates upon presentation of the proper credentials
- Sec.5 State Auxiliaries are entitled to representation at the National Convention. Such delegates shall have a total of ten (10) votes. One or more delegates shall cast the full number of votes to which their state is entitled, provided that no vote is divided smaller than one (1) vote per delegate. A state delegate cannot act as a delegate for his or her respective local auxiliary.

ONLINE DELEGATE REGISTRATION FOR LOCAL, STATE, MAL OR LWOL – is available at www.apwuauxiliary.org for all delegates. Please remember in order to be seated at the National Convention delegates must bring a completed credential, signed by the President and Secretary of the Auxiliary they are elected to represent and present it to the Auxiliary registration desk at the Convention Center..

MAL and LWOL delegate credentials are signed by National President & Secretary.

LOCAL CREDENTIALS, MEMBERS AT LARGE/LOCALS WITHOUT LEADERS (LWOL)

Credentials shall be automatically issued to the Local Auxiliaries in good standing as of January 1, 2016 provided they participated in the 2014 National Convention. For Locals who did not participate in the 2014 National Convention: Credentials must be requested by the local president via letter, e-mail or fax from the National Secretary—Patricia Lewis, 1500 30th Street, Richmond, Virginia 23223 or online at www.apwuauxiliary.org. Credentials will be promptly mailed from the Secretary's office to the Local President when the above information is received.. As soon as delegates have been elected, the delegate's name, address and respective local Auxiliary should be sent by the Local President to the National Secretary.

NOTE: Only the local President should make credentials requests. This is to eliminate receiving duplicate requests for credentials in the Secretary's office.

MEMBERS AT LARGE AND LWOL'S must request credentials via letter, e-mail, online or fax from the National Secretary—Patricia Lewis, 1500 30th Street, Richmond, Virginia 23223.

STATE CREDENTIALS:

Credentials will be mailed to the State President. Return the completed original copy, signed by State President and State Secretary, to the National Secretary not later than July 22, 2016, thirty days prior to the convening of the convention.

Duplicate credentials should be filled in and retained by the delegate or the member-at-large to be presented at the registration desk at the convention.

Alternate credentials should be filled in and retained by the alternate delegate to be presented at the registration desk at the convention in the event the elected delegate is unable to attend.

Credentials should be filled out as directed and signed by properly authorized officers. APWU credentials will not be accepted as Auxiliary delegate credentials. If delegates are selected too late to request credentials, the delegate must bring to the convention a letter, signed by the President and/or Secretary certifying that they are representing their Auxiliary. This letter should be presented at the Auxiliary Headquarters Office at the convention and credentials will be issued. When credentials have not been issued, delegates will be required to have a letter or a telegram for verification showing they are authorized delegates. Personal verifications cannot be accepted.

RESOLUTIONS:

Resolutions must be prepared in duplicate and signed by respective officers or delegate(s). Only one resolution may appear on a page and each resolution should have an appropriate title. To be printed in the Resolution Booklet, resolutions must be received on or before July 1, 2016. All resolutions must be accompanied by a financial impact statement. Statements will be forwarded by the National Secretary to the National Treasurer for verification of the accuracy of the impact statement.

Prior to the convening of the National Convention, resolutions shall be sent to the National Secretary. The National Auxiliary requires resolutions submitted via fax or email to also have an original signed copy of the resolution sent via the US Postal Service to the National Secretary. The original copy should be sent to the National Secretary, Patricia Lewis 1500 N. 30th Street, Richmond, Virginia 23223. The duplicate copy should be sent to the National President, Kathy Danek, 4261 Knox St, Lincoln, NE 68504.

Resolutions submitted after July 1, 2016 and prior to 12:00 noon August 22, 2016 (the first day of the National Convention) will be presented to the Convention for consideration and action, but may not appear in the Resolutions Book. Resolutions presented after 12:00 noon August 22th will be considered in accordance with the approved rules of the 2016 National Convention. Resolutions may be e-mailed to the Secretary at Netta15@aol.com. A signed copy of the resolution must still be mailed to the President and the Secretary.

NOTE: No delegates may switch status after registration at all, except in the case of an alternate delegate who may switch only once. No further registration of delegates after 5:00 PM of the day preceding nominations at the National Convention. All delegates who wish to be withdrawn from delegate status must request it in writing or report it to the National President.

Zika Virus

About the Health Plan

Zika virus is spread to people through mosquito bites. The most common symptoms of Zika virus disease are fever, rash, joint pain, and conjunctivitis (red eyes). The illness is usually mild with symptoms lasting from several days to a week; hospitalization is uncommon.

Outbreaks of Zika have occurred in areas of Africa, Southeast Asia, the Pacific Islands, and the Americas. Because the *Aedes* species mosquitoes that spread Zika virus are found throughout the world, it is likely that outbreaks will spread to new countries. In December 2015, Commonwealth of Puerto Rico reported its first confirmed Zika virus case. Local vector-borne transmission of Zika has not been reported elsewhere in the United States, but cases of Zika have been reported in returning travelers

Zika virus and pregnancy

Zika virus can be spread from a pregnant woman to her unborn baby. There have been reports of birth defects and other poor pregnancy outcomes in babies of mothers who were infected with Zika virus while pregnant. Until more is known, CDC recommends special precautions for the following groups:

Pregnant women should consider postponing travel to the areas

where Zika virus transmission is ongoing. Pregnant women who must travel to one of these areas should talk to their doctor or other healthcare professional first and strictly follow steps to avoid mosquito bites during the trip. Until we know more, if your male sexual partner has traveled to or lives in an area with active Zika virus transmission, you should abstain from sex or use condoms the right way every time you have vaginal, anal, and oral sex for the duration of the pregnancy.

Women trying to become pregnant should consult with their healthcare professional before traveling to these areas.

Scientists at CDC and the Pan American Health Organization are working with public health experts in Brazil and other affected countries to investigate the possible link between Zika virus infection and microcephaly.

Warning Signs of Chronic Childhood Hunger

The Portland, Maine Auxiliary wanted to donate locally to the **Feeding America Backpack Program** and in doing some research as to where to give in the Portland Area I came across the following information about **Warning Signs of Chronic Childhood Hunger**. (Source: "Junior League of Portland Maine")

- Pocketing or hoarding food on Fridays to bring home for the weekend.
- Lingering around cafeteria or other locations with food and frequently asking for seconds.
- Appearing anxious for meals to be served
- Rushing to cafeteria or showing up early for breakfast on Mondays
- Consistently complaining of headaches, stomachaches, or falling asleep in class on Monday mornings.
- In addition to these warning signs you may also see an impact on the child's ability to function at school.
- A chronically hungry child may exhibit excessive absences, difficulty forming friendships, irritable behavior, and excessive sickness

- "I love the Backpack Program. It really does help us get through the month because we don't get enough in food stamps to last us. Thank you and God bless!"
- "Many of the children who participate are the ones who try to save some of their lunch food or school provided snacks to take home. I'm sure the extra food is used up every weekend. Thank you!"
- "It is amazing to see my students excited faces when they receive their Backpacks they know they will have food to eat for the weekend!"
- "The Backpack Program is a true blessing! We are two parents who are experiencing an array of illness and loss of work. It helped us so very much to get this help that allows us to worry a little less about an essential part of our lives meals."

Remember to File Your 990N

The *e-Postcard* is due every year by the 15th day of the 5th month after the close of your <u>tax year</u>. For example, if your tax year ended on December 31, the *e-Postcard* is due May 15 of the following year. If the due date falls on a Saturday, Sunday, or legal holiday, the due date is the next business day. **You cannot file the** *e-Postcard* **until after your tax year ends.**
