If approval is granted, it is not to be construed to include approval of any city or county code requirements. A building permit from the appropriate city or county building department is needed on most property alterations or improvements. The Architectural Committee shall have no liability or obligation to determine whether such improvements, alterations or additions comply with any applicable law, rule, regulation, code or ordinance.

As a prerequisite for granting approval of any request for a change, alteration or addition outside of or to an existing basic structure, the applicant, their heirs and assigns must assume sole personal and financial responsibility for the repair, replacement, maintenance and upkeep of any such change, alteration or addition. It is understood and agreed that Shiloh Property Owners' Association, Inc., the

Architectural Committee, [REDACTED] et al. are not required to take action to repair, replace or maintain any such approved change, alteration or addition to any structure or property.
