The Mazo Downtown Market is held at 18 E Hudson St on the lawn in downtown Mazomanie.

### Fees

- The full season (5 weeks) fee is \$75, payable with this application.

## Liability Insurance

Vendors are required to provide proof of liability insurance as a condition for selling at the mazo

Downtown Market. Your insurance agent can give you a one-page “Certificate of Insurance.” It must show coverage of no less than \$100,000 and list the vendor’s name and address. This certificate should be included with your application. No vendor will be permitted to vend without this Certificate of Insurance. Please see example on website.

**Covenant to hold harmless**

The vendor agrees to indemnify and save The Apothecary & Mercantile and the Downtown Mazo Market harmless against and from any and all claims, damages, costs and expenses, including reasonable attorney’s fees, arising from the conduct or management of the business conducted by vendor at the Downtown Mazo Market.

**Loss or damage of property**

Apothecary & Mercantile of Mazomanie and the Downtown Mazo Market shall not be liable for any damage to property of vendor or of others located on the leased stall, nor for the loss of or damage to any property of vendor or of others by theft or otherwise.
