Effective July 2025 billing cycle the water rates will be increasing by \$5/quarter due to rising costs for infrastructure maintenance and water treatment.

Please Note: <u>ALL</u> swimming pools over 28" -this includes new, pre-existing, and/or temporary pools are required to have a safety alarm. Any outdoor swimming pool, including above ground or in ground pool, **MUST have a barrier** which shall comply with State code regulations [4 feet in height with a locking gate].

A building permit is required before installing new pools, spas, and hot tubs having a depth of more than 28".

The Village must receive a certificate from the electrical inspection agency BEFORE using the pool. **No one may use a pool, spa or hot tub until a certificate of compliance has been issued by the Code Official**. Swimming pool regulations can be obtained by contacting your Code Enforcement Officer at (607) 542-2175.

There will be no warnings issued in regards to this NYS regulation. All must comply or an appearance ticket will be issued and fines can be as much as \$250 for every day the violation exists.

Permits are needed to have a yard/garage sale in the village. Please contact the clerk to have one issued.
