

Bloomfield Police Department

Monthly Report for April 2018

This is the monthly report for the Month of April 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Wednesday, April 4th at approximately 7:36am officers responded to a personal injury motor vehicle crash at the intersection of Hwy U and Eastside Road. At the conclusion of the investigation a 30-year-old female was issued a traffic citation for driving too fast for conditions.

On Monday, April 9th at approximately 5:00pm officers responded to an address on Hwy H for a vehicle parked on the property that appeared to be abandoned. At the conclusion of the investigation it was determined that the vehicle had been reported stolen out of Chicago, Illinois. The vehicle was impounded and ultimately returned to the legal owner.

On Tuesday, April 10th at approximately 4:39pm officers responded to Lakeside Country Store for a battery complaint. A 38-year-old female reported that after exiting the store she was approached by a male subject who punched her in the face one time then fled the area driving an older red Pontiac Grand Am or Grand Prix. The victim described the male as possibly a male white who was approximately 5'08 tall. Anyone having information about this battery complaint is asked to contact the police department.

On Tuesday, April 10th at approximately 7:30pm officers responded to a theft of motor vehicle complaint. The complainant reported that he had parked a trailer hauling a 1989 Ford van on Thunderbird Road after the towing vehicle had experienced mechanical problems. Upon returning to where he had left the trailer he discovered that person(s) unknown had stolen the trailer and vehicle. The vehicle was entered as stolen and the theft remains under investigation.

On Saturday, April 14th at approximately 8:00am officers responded to a theft from motor vehicle complaint on Hawthorn Road. It was reported that several items were taken from the unlocked vehicle. This theft remains under investigation.

On Saturday, April 14th at approximately 10:22pm officers responded to a burglary complaint on Celadine Road. The homeowner reported that person(s) unknown forced entry into the home removing several items. Information surrounding this incident has intentionally been withheld from this report as the incident remains under investigation.

On Friday, April 20th at approximately 10:07am officers executed a traffic stop on Hwy H for a traffic violation. At the conclusion of the traffic stop a 41-year-old female was arrested and confined in the Walworth County Jail. A charge of felony bail jumping was forwarded to the Walworth County District Attorney's office. Additionally, she was issued traffic citations for speeding, operating after suspension and operating a motor vehicle without insurance.

On Sunday, April 22nd at approximately 11:25am officers responded to a theft from motor vehicle complaint on Chicago Drive. It was reported that several items were taken from the unlocked vehicle. This theft remains under investigation.

On Tuesday, April 24th at approximately 3:02am officers responded to the Blue Top Motel on Hwy H for a male subject screaming. At the conclusion of the investigation a 34-year-old male was arrested and confined in the Walworth County Jail. Charges of possession of cocaine, possession of drug paraphernalia and disorderly conduct have been forwarded to the Walworth County District Attorney's office.

On Wednesday, April 25th at approximately 10:55am officers responded to an address on Lincoln Drive in Lake Ivanhoe for a disorderly conduct complaint. At the conclusion of the investigation a 55-year-old female was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office. Additionally, she was issued traffic citations for failure to stop at a stop sign and reckless driving stemming from the same incident.

On Wednesday April 25th at approximately 2:19am officers responded to the Blue Top Motel on Hwy H for a disorderly male subject in the parking lot. At the conclusion of the investigation the same 34-year-old male who had been arrested on April 24th was arrested again and confined in the Walworth County Jail. Charges of possession of cocaine, possession of drug paraphernalia, felony bail jumping and disorderly conduct have been forwarded to the Walworth County District Attorney's office.

On Sunday, April 29th at approximately 11:15pm officers responded to a residence on W. Lakeshore Drive for an unwanted disorderly subject. At the conclusion of the investigation 26-year-old male was arrested and confined in the Walworth County Jail. Charges of battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office.

During the month of April 2018 the police department affected 155 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 100 arrests during the month of April 2017.
