## COVENANT NOT TO SUE AND INDEMNITY AGREEMENT

This Covenant Not To Sue and Indemnity Agreement is executed this \_\_\_\_\_ day of \_\_\_\_\_, 2019, by and between the undersigned, including all of its officers, directors, employees, members and participants (the "Participant"), and **Stuart Christmas Parade, LLC.**, including their respective officers, directors and members."

Whereas, **Stuart Christmas Parade, LLC.**, is the organizer of the 59th Annual Stuart Christmas Parade ("Parade") which is located on property and public rights of way owned and operated by the **City of Stuart, Florida and State of Florida.**

Whereas, Participant desires to participate in the Parade.

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and in consideration of Participant participating in the Parade, and the undersigned having the authority to sign this agreement, and intending to be legally bound, the parties agree as follows:

1. The Participant covenants that it shall not sue **Stuart Christmas Parade, LLC., or Visiting Nurse Association of Florida, Inc.** or any of their respective directors, officers, employees or agents for any action, claim or otherwise arising out of Participant's participation on the Parade; and further

2. Participant does hereby indemnify and hold harmless the **Stuart Christmas Parade, LLC., and Visiting Nurse Association of Florida, Inc.** (collectively the "Indemnities") from any and all cost, loss, damage or liability the Indemnities may incur, including without limitation, attorney's fees at all levels, arising directly or indirectly from the Participants participation in the Parade including any matters arising before or after the Parade. The Indemnities shall have the ability to engage their own counsel (individually or collectively) to defend any claim or threatened claim or cause of action covered by this indemnification. Furthermore, the indemnification and hold harmless provided herein shall not be deemed to be exclusive of any rights to which the Indemnities are entitled under any statute, rule of law or theory of law. Where any other remedy provides broader rights of indemnification than those provided herein the other remedies shall control."

## RULES FOR PARTICIPATION AND PARADE ROUTE DETAILS

- ✓ All vehicles and entries must have a minimum of 1,000 lights and be theme decorated.
- ✓ You are required to provide a Certificate of Insurance showing liability coverage for your organization. Please ask your insurance agent to provide this.
- ✓ We have enclosed a NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN document which is in the form set out in FL Statute 7447.301. We recommend that you insert the proper name of your organization in the form and, for your organization's protection, have a form completed by each family.
- ✓ All entries will be assigned a line-up number and receive further instructions upon arrival on parade day.
- ✓ Floats towing children **MUST** have railings and an adult on the float. Children must be securely placed in a car, float, or other vehicle. **All children must be supervised by an adult.**
- ✓ **Alcoholic beverages are not permitted** on any float and in any vehicle. Participants consuming alcohol prior to or during the parade will be removed from line-up and barred from subsequent parades. All City of Stuart, Martin County, and State of Florida Statutes concerning the consumption of alcoholic beverages will be strictly enforced by the police.
- ✓ **PLEASE** arrange for Event Day Greeter/Drop Off chaperone for all minors.
- ✓ Throwing of candy or handing out any type of information, brochures or flyers to the crowd is prohibited. Candy may be handed to spectators, without slowing parade progress. Blowing snow off the float is not allowed.
- ✓ Parade organizer reserves the right to ban from parade any entrant not conforming to rules and regulations, not keeping pace, or refusing to follow instructions of the police or parade officials. Parade officials reserve the right to accept or decline any entry.
- ✓ All marchers or walkers must be suitably costumed and/or dressed in a uniform that identifies them as part of the same group.
- ✓ No participant can be dressed as Santa or Mrs. Claus. **SANTA HATS ARE OK.**
- ✓ Only one entry per form. Please copy and complete if you need another form. Each entry requires the appropriate entry fee. **Each entry is for one business only**, you cannot share an entry with another business.

- ✓ Actual float size limited to 40 feet long & 10 feet high from the ground up. **Please keep space and navigation limitations in mind when designing floats.**
- ✓ If you have a generator on your float, we recommend having additional fuel on hand due to idle time during the parade.
- ✓ Distance between parade units is to be maintained at 30 feet. All units are required to close the gap when requested to do so by parade officials.
- ✓ Application fees are non-refundable for accepted entries.
- ✓ Line-up is on Monterey Road beginning at Kingswood Terrace.
- ✓ Drop-off is at Smithfield Plaza with vehicle entry at the Monterey entrance.
- ✓ Parade route begins on SE Ocean Boulevard at Monterey Road and ends at Georgia Avenue.
- ✓ Vehicles with no need to disband will stay on Ocean and exit via the traffic circle.
- ✓ Vehicles that do need to disband will exit onto Georgia Avenue and be directed by volunteers.
- ✓ Buses will leave drop-off and park at Stuart Middle School in the first lot adjacent to Ocean Boulevard.
- ✓ All judging will happen as floats and bands pass the judging booth in the Grandstand.

#### **ALTERNATIVE ARRANGEMENTS FOR DISBANDING**

**Fencing will be added to help manage the flow of participants and the public at the junction of Georgia Avenue and SE Ocean Blvd. It is becoming increasingly dangerous and difficult to turn floats onto Georgia Ave. **Please make arrangements to meet your disbanded participants away from this area**, such as at the parking lot on SE Stypmann Blvd and SE Flagler Ave, as this will be much safer.**
