- Closed Issues—5 irrigation, 3 tree, 1 gate, 2 remote/control box, 2 HOA demand requests
- Open Issues—Street light on Allen St. and courtyard bush trimming for a homeowner
- In Progress—2 violation notices will be sent out regarding parking on the sidewalk and block wall painting repair.

### **New Business:**

- Board Officer Appointments—Officers were re-elected into office during the Annual HOA Meeting in May.
- Annual Tree Maintenance--\$4800 is allocated for tree maintenance for 118 existing trees in the community.
- Block Watch Grant Updates—The 4<sup>th</sup> quarter report was filed and remaining monies have been transferred back to the city.
- Solar Lights Vandalism—3 incidences of solar vandalism have occurred: 2 at the Euclid pedestrian gate and 1 at the community ramada space.

#### **Old Business:**

• Winston Entry/Exit Gate Replacement Updates—The entry gate has been completed. The exit gate rebar design needs to be fixed to match design plans and community aesthetic.

## **Open Forum:**

- We are 6 months from our painting deadline.
- The American flag was replaced with a new one due to wear and tear from storms.
- October potluck was proposed.
