CCR'S CORNER

It is not only important for every homeowner to be familiar with the CCRs for compliance, but also to understand their own rights baked into them. In this issue of CCR Corner, the Board would like to highlight Article 9.4 Certificate of Compliance. After an approved project has been completed, a homeowner can request a Certificate of Compliance which is a document completed by the Architectural Committee suitable for recordation by the homeowner. Essentially it is a document that proves that a project was approved by the AC when a homeowner goes to sell their house or when there's turnover on the Board and there's a question as to whether something was approved prior.
