### Pick-Up/Drop-Off

In order to create the safest, easiest drop-off and pick-up for our campers and families, we will be running an express lane, directly at the front of Imagi Nation. Your camper(s) will be met at the car by our counselors and escorted into the facility. Guardians will receive a name plate to place on their dashboard during pick-up and drop-off times to allow for clear, easy communication between guardians and counselors. You will enter the express lane from Hamilton Blvd and parents will be able to exit directly back onto Hamilton Blvd or take the parking lot to the front side of the shopping center. Please see the map below for clarification. Any camper(s) dropped off prior to 8:50am or picked-up after 4:10pm will be charged for before/after care.

*Early Pick-Up or Late Arrivals* – If you need to pick your child up early, please be sure to send a note with them so we are able to have your child ready for you upon your arrival. If you need to drop your child off late, please park in our parking lot and then walk-into Imagi Nation, where you will be greeted by a counselor!



## **Enrollment/Withdrawal/Payment**

Imagi Nation reserves the right to cancel or change any camps due to low enrollment. A \$75 non-refundable deposit will be due per child, per week of camp at registration. If the camp is cancelled due to low enrollment, this deposit will be refunded. If a camper needs to withdraw within one week of their start date, a request for a credit voucher may be submitted, to be used within one year for any camp related programming, such as School's Out Camp. Credits will be \$75 less due to the non-refundable deposit for each week of camp.

Payment for each camp must be received in full, one week prior to the first day of the camp. A \$20 per day late fee will be assessed for each payment received after the deadline. Any new camp registrations that occur within one week of camp commencement will incur a \$45 late registration fee. Any checks returned for non-sufficient funds, declined credit cards, or other issues voiding the payment, will incur a \$50 fee.

The camp fee of \$285 for full-day camp/\$ for 3 and 4 year old's half day camp is inclusive of all materials and snacks for your camper. There is no additional activity or material fee. The lunch package, which includes a lunchtime meal for the week, can be purchased for \$47.50. There is not a daily lunch option. If a camper is sent to camp without lunch, a \$15 fee will be charged to provide the child lunch.

## **Attire**

Campers will be participating in fun, educational activities and sometimes this can be messy! Please be sure to send you camper in comfortable clothing that could potentially become wet or dirty. Sneakers are recommended as campers will be moving throughout the day. Please keep the weather in mind, as there may be times spent outdoors. Feel free to send sunscreen in with your camper and it will be applied before we head outside.

## **Behavior Expectations**

The number one priority of Camp Imagine is to create a safe space for our campers and counselors. This requires campers to be listening, cooperating and following all directions issued by our counselors. If a camper refuses to follow direction and/or places themselves or others in a potentially dangerous situation, Imagi Nation retains the right to dismiss the camper from the remaining camp session without a refund. If a serious discipline issue arises with a camper, parents/guardians will be notified immediately, and the camper will be removed from the camp setting. No physical altercations (including kicking, biting, self-harming, etc.) or verbal abuse (name calling, inappropriate language, etc.) will be tolerated. By sending your child to Camp Imagine, you and the child are agreeing to follow all policies set-forth via the camp and its staff. I understand that I am responsible for all damage - intentional or unintentional - done by my child(ren) to Imagi Nation property.

## **Electronics**

Imagi Nation is not responsible for any damaged or lost items and this includes any electronics a camper chooses to bring. There will not be time during the day to play with any electronics, therefore it is highly recommended that electronics be left at home. If you would like your camper to attend with a cell phone, that phone will remain with the camper's belongings throughout the day and they will not have access to it during camp. If at any point you need to reach your camper, you can call Imagi Nation at 610-841-5919 and our staff will provide any assistance necessary.

## **Release of Liability**

The undersigned individual desires to use the Imagi Nation facility (referred to as the "Facility") and/or to participate in activities or programs (collectively the "Activities") sponsored by or involving DNL Enterprises LLC. In consideration for DNL Enterprises LLC's permitting me and/or my child(ren) to use the Facility and permitting me and/or my child(ren) to participate in the Activities, I have agreed to execute this Release of Liability (the "Release").

*COVID-19:* The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown, and there is no known treatment, cure, or vaccine for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death. DNL Enterprises LLC cannot prevent you or your child(ren) from becoming exposed to, contracting, or spreading COVID-19 while utilizing DNL Enterprises LLC's services or premises. It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize DNL Enterprises LLC's services and/or enter onto DNL Enterprises LLC's premises you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

*Assumption of Risk:* I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my child(ren) in order to utilize DNL Enterprises LLC's services and enter DNL Enterprises LLC's premises. These services are of such value to me and/or to my child(ren), that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to utilize DNL Enterprises LLC's services and premises in person. **WAIVER OF LAWSUIT/LIABILITY:** I hereby forever release and waive my right to bring suit against DNL Enterprises LLC's and its owners, officers, directors, managers, officials, trustees, agents, employees, or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing DNL Enterprises LLC's services and premises. I understand that this waiver means I give up my right to bring any claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.

*Activities:* I acknowledge that using the Facility and participating in the Activities may involve certain inherent risks, including the risk of personal injury and allergies or reactions to certain foods. I agree to

assume all such risks, as well as any other risks involved in using the Facility, participating in the Activities or participating in any other activities sponsored by or involving DNL Enterprises LLC's. I release and discharge DNL Enterprises LLC's and all of its employees, agents, representatives, partners, and members, as well as all other persons or entities that may own, operate or manage the Facility, as well as any and all other persons or entities that might have any liability whatsoever to me related to the Facility, the Activities, or DNL Enterprises LLC's (collectively, the "Released Parties"), from and against any and all damages, claims and liabilities, whether known or unknown, anticipated or unanticipated, suspected or unsuspected, relating to or arising from any activity, occurrence or event involving, related to, or arising out of the Facility, the Activities, or DNL Enterprises LLC's. This Release is intended to release and discharge the Released Parties from all damages, actions, claims and liabilities of any nature, specifically including, but not limited to, damages, actions, claims and liabilities arising from or related to the negligence of the Released Parties. I further agree to indemnify, hold harmless and defend DNL Enterprises LLC's and each of the other Released Parties from and against any loss, damage, liability and expense, including costs and attorneys' fees, incurred by DNL Enterprises LLC's or any of the other Released Parties as a result of my using the Facility, participating in the Activities, or participating in any other activity sponsored by or involving DNL Enterprises LLC's.

**Photo Release**

DNL Enterprises LLC's reserves the right to use any photograph taken at the Facility, or in connection with any Activities or other activity involving DNL Enterprises LLC's, including but not limited to those taken during a program, a birthday party, a group event, or other Activity, to be used in DNL Enterprises LLC's promotional materials, brochures and website.

I represent that I am the parent or legal guardian of the individual named below and hereby consent to the individual using the Facility, participating in the Activities, and participating in other activities sponsored by DNL Enterprises LLC's. In consideration for DNL Enterprises LLC's allowing the named individual to use the Facility, participate in the Activities, and participate in the other activities, I agree, personally and on behalf of the individual, to be bound by the terms and conditions of this Release. I further agree to indemnify, hold harmless and defend DNL Enterprises LLC and all other Released Parties from and against any loss, damage, liability and expense, including costs and attorneys' fees, incurred by DNL Enterprises LLC or the other Released Parties as a result of the above individual using the Facility, participating in the Activities or participating in any other activity involving DNL Enterprises LLC.
